Thank you to everyone that came out to our 115th NC State convention. I also want to thank Susan Knapp (Director of Steward Operations) for attending and for the information she presented to us. We look forward to seeing her at the National Convention in Texas.

Brian Hamlett was elected as our new 3-year executive committeeperson. He will be handling our retirement articles. Congratulations Brian! We will all miss Renee Johnson and wish her well in her new adventures. She has been an exceptionally intelligent and resourceful member of our team.

We received some questions at the state convention that I wanted to answer for everyone.

- 1. Could state officers have meet and greet meetings on a local level to help put a face to our union? We will gladly meet at the District level. Districts are not restricted to just one meeting per year. Some districts have 3 or 4 meetings each year. Each district has a state officer assigned to them.
- 2. What has happened to the NC RLCA website? It was up and running when Jeff Essick was webmaster, but it is not anymore. We were advised that a conflict of interest was present with a fulltime National Union Official working as our webmaster, so we made a change. We also wanted to change the website from .com to .org so we moved the site to ncrlca.org. We unveiled the new site at the State Convention. It should be fully functioning very soon.
- 3. Why do we keep having conventions in Cherokee? Sometimes we have them more than one year in a row. We don't do this for any other city. Why don't we go to other places in the western part of the state? Cherokee is our most attended convention site. It is also where we get some of the best deals on rooms and meeting space. We must have a large facility with plenty of meeting space. We have been to Boone and Asheville.

As I am writing this article we are preparing for the Contract Ratification Meeting at Embassy Suites in Greensboro on Saturday July 13 at 6:00pm and the National Convention in Grapevine, Texas August 13 -16. I want to thank each of you for allowing me to serve as your President for the 2018/19 year. It has been a most enjoyable and educational time for me. Your state board has made some significant changes in our ability to communicate with you thru the NCRC magazine and on the website. We strive to keep you informed of all matters that concern us as rural carrier families. We are available by mail, phone and email (remember we are carriers also and are usually carrying our routes during the day).

Audrey and I attended the Legislative Seminar in Washington, DC May 18-21. After a 2-day training seminar we began our meetings on Capital Hill.

Ted Budd (13th district)

None of these Representatives have signed on as cosponsors on any legislation but are willing to support a permanent solution for the Postal Service. Mark Meadows has called for Meghan Brennan's 10-year plan and says he will work for longterm legislation once he receives her plan. Many members that we spoke with in the House and Senate are waiting for his proposal.

G. K Butterfield(1st district)

Alma Adams(12th district)

Representative's Price, Butterfield and Adams have already cosponsored H. Res. 23, H. Res. 33, H. Res. 54 and H. Res. 60.

Representative Adams has also cosponsored H.R. 2382.

Virginia Foxx (5th district). She is on the Oversight and Reform Committee.

The aide for Representative Foxx stated that she is waiting for it to come to the floor for a vote.

Representative Mark Walker (6th district)

The aide for Representative Walker stated that **he** was for partial privatization.

This legislation is in the House.

Don't Be A Victim!

Hello all, I hope you are enjoying your summer. It is always important to remember to hydrate completely this time of year, before, during, and after work especially. The idea of hydrating is to drink so you will not become thirsty. Breaks become essential this time of year, sometimes to simply seek shade and cool down. Safety is our responsibility and can be a huge challenge this time a year with the soaring temperatures outside which intensifies when we're in the LLV or POV serving our routes.

I wanted to touch on a subject that is becoming more and more prevalent in this day and age. With the recent shootings in Charlotte on the campus of UNCC, the active shooter situation is a tragedy that can happen anywhere at any time. This can take place while we are on the job or while we are off duty. The *active* aspect of the definition inherently implies that both law enforcement personnel and citizens have the potential to affect the outcome of the event based upon their responses to the situation.

The sanctity and security of the mail becomes a secondary concern when our lives become endangered. If such an event should happen while on duty, get to safety immediately, then call 911 and your Supervisor.

There is simply no time in our day that we can let our guard down. We must always stay vigilant when it comes to being aware of our surroundings.

I know the nature of being a rural carrier and the selflessness, public servant, kind, helping, etc.... personality that comes along with the job. I have no doubt that some of us would rise to the occasion and do what we could to remedy the situation.

Being a hero can be fatal. The events that took place in Charlotte attest to just that. A student tackled the gunman; giving time for others to get to safety unharmed. **HERO** defined but at a tremendous loss. Rest in Peace Riley Howell.

The FBI has designated 27 shootings in 16 states in 2018 as active shooter incidents. 213 casualties, 85 killed, with 128 wounded. The numbers are truly alarming.

Whether on duty or not, stay aware, stay safe. Safety is carrier discretion, if at any time, our safety is at risk, we have the responsibility to get to safety, report the issue, and let the authorities take control.

I hope none of us ever has to deal with such a tremendous tragedy, but we should at least consider that it could happen to any one of us. Thinking about what you would need to do and preparing a plan of action can help us feel more in control should the need ever arise.

EMA Increased to 74.5 cents/mile

On June 12, 2019, the Bureau of Labor Statistics released the May 2019 Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W) which established the Private Transportation Index at 211.792, an increase from the February 2019 Index of 199.460. Therefore, based on the May 2019 CPI-W release, the Equipment Maintenance Allowance (EMA) for rural carriers will increase 4.5¢ to 74.5¢ per mile.

This EMA rate will be effective July 6, 2019.

EYE HEALTH FOR TODAY & INTO TOMORROW

You know protecting your skin from the sun's harmful rays is important, as I talked about in my last article, but do you know the importance of protecting your eyes? Protecting not only on sunny days but those cloudy days too and from occupational hazards we have while on the job.

Maybe someone is mowing/weed eating their lawn and a projectile is flying in your direction. This recently happened to a carrier as they were turning onto a secondary roadway. A customer was on their riding mower and as the carrier came around the corner, a rock flew up and hit the top of the window. It left a dent where it hit! What if that projectile was a bit lower? They could have been hit in the corner of their eye or face. It was a very scary incident for this carrier.

There are many hazards out there that we could encounter that may affect our eyes. Pollen and dry dirt roads will cause your eyes to get irritated. Out of instinct we rub them. That can cause the dirt to scratch the cornea causing a very painful corneal abrasion.

As we walk up to make deliveries you may encounter those small bugs that swarm together. One can get in your eye as well. Over the counter lubricating eye drops are a great thing to have on hand to help with these situations.

Protect your eyes year-round, not only from hazards on the job but during your recreational time too. Whether on the water fishing or skiing in the winter, glare bouncing off the surfaces can harm your eyes.

As I wrote in the last issue sun glasses with 100% UV protection from both UVA and UVB rays will help



protect your eyes from sunburn, agerelated macular degeneration, cataracts, blindness, and even cancer of the eyelids. Add to that a floppy hat, visor or baseball cap and not only are you protecting your skin but your eyes too.

Everyone from babies to adults should wear sunglasses. It's a good habit to start at a young age since their eyes are more sensitive to light than ours.

There are many styles to choose from, including prescription sunglasses, so you don't have to sacrifice style to get the eye protection you need.

Here's some things you can expect to notice as your eyes age.

Adults in their 20s and 30s generally have healthy eyes and can effectively treat vision problems with corrective eyeglasses or contact lenses. It's never too

early to start preserving your eye health! During this stage of life, prevention is key.

In your 40s, you may notice that your near vision isn't as

sharp, making it harder to read smaller print and you may begin relying on reading glasses.

As we reach our 50s and beyond the risk of agerelated eye diseases such as glaucoma, cataracts, and macular degeneration increase. While cataracts are technically classified as an age-related eye disease, they are so common many consider it a normal part of the aging process.

You may not notice you have cataracts because the clouding of your natural lens happens gradually over time. Problems with glare, especially when driving, can also be related to a maturing cataract. Some agerelated diseases are difficult to prevent due to genetics, lifestyle and environmental factors. We should still do everything we can to delay disease progression.

Regular eye exams are a great way to keep track of your ocular health. If you notice any changes in your vision you should contact your vision provider, even if you think it'll correct itself. This may be your bodies way of telling you something is wrong.

Many may not know that other problems such as diabetes, stroke, cancer and even Multiple Sclerosis can be detected through an eye exam. If your Doctor suspects one of these may be causing your vision problems, they may refer you to another specialist for further testing.

214 cosponsors as of June 11, 2019 Referred to the House Committee of Oversight and Reform on January 4

H.Res.33- Expressing the sense of the House of Representatives that Congress should take all appropriate measures to ensure that the United States Postal Service remains an independent establishment of the Federal Government and is not subject to privatization.

253 cosponsors as of June 11, 2019

Referred to the House Committee on Oversight and Reform on January 9

<u>H.Res.54</u>- Expressing the sense of the House of Representatives that the United States Postal Service should take all appropriate measures to ensure the continuation of its 6-day mail delivery service.

254 cosponsors as of June 11, 2019

Referred to the House Committee on Oversight and Reform on January 16

<u>H.Res.60</u>- Expressing the sense of the House of Representatives that the United States Postal Service should take all appropriate measures to restore service standards in effect as of July 1, 2012.

169 cosponsors as of June 12, 2019

Referred to the House Committee on Oversight and Reform on January 1

H.R.2382- USPS Fairness Act.

112 cosponsors as of June 12, 2019

Referred to the House Committee on Oversight and Reform on April 29

H.R.2478- Federal Retirement Fairness Act.

There are only 18 cosponsors.

Referred to the House Committee on Oversight and Reform on May 2

<u>S.Res.99</u>--_A resolution expressing the sense of the Senate that Congress should take all appropriate measures to ensure that the United States Postal Service remains an independent establishment of the Federal Government and is not subject to privatization.

Referred to the Committee on Homeland Security and Governmental Affairs on March 7 Senator Burr nor Senator Tillis are on this committee.

Legislative Seminar May 18-22

I have heard over the years about all the walking involved in this visit. You truly get your exercise and learn to be a lobbyist for the Postal Service. The experience was awesome, but we need YOU to write or call your Representative and Senator.

Recruit A Friend Today (RAFT)

North Carolina has implemented a "RAFT Recruiter Raffle" as an incentive for our members to continue with their efforts of enlisting new members. We will have a drawing at the end of each quarter. Every quarter

the names of all recruiters will be placed in the hat for a chance at winning a \$250 prize.

The last drawing will be on September 30, 2019. This pool of names will be from all the new members recruited during the previous quarter (April 1 - June 30).

New members must still be employed with the rural craft 90 days after their enrollment date. Any member that has separated or moved to another craft within those 90 days is ineligible.

We were told how important having correct information is; not only for us but also to the USPS and the mailers. Many questions were answered by her team.

Susan Knapp, National Director of Steward Operations, was our guest speaker from the NRLCA. Some of the main points in here address were:

- The RRECS (Time Study as most of us call it) ~ This is still a work in progress. It will be some time before it is implemented. All route mapping must be completed first. Also the USPS and our union must still negotiate many aspects before it can be executed.
- 2) The proposed contract ~ Ms. Knapp urged everyone to attend the ratification meeting to get a complete explanation of the changes.
- 3) New postal vehicles ~ New protype vehicles are being tested now. They are no where near being produced. It will most likely be a few years before they will be in use by the USPS.
- 4) Our scanners ~ The scanners are going to be the backbone of the way we get paid under the new system. Please make sure you are taking your scanner with you and are scanning everything appropriately. The new system will be an average of our year, not what we did in a 2-4 week period.
- 5) $4003 \sim$ Make sure your 4003 is correct and that you are following your line of travel.

New Constitution Language

Passed at the 2019 State Convention

ARTICLE IV Section 1. Subordinate Units

B. The Districts of the State Association shall be composed of 31 districts.

Article VI. Section 4. State Delegate Compensation

- A. State delegates shall be compensated up to \$100.00 per business session day of attendance at the State Convention for expenses.
- B. The state shall set aside a total amount equal to the rate of .00017% of a 40 hour, Step C, Table 1 regular rural carrier's yearly pay for each member on the rolls on June 30, to be used to pay state delegates. (proviso first deposit will be July 2019)
- C. These funds shall be held in an interest-bearing account.
- D. The maximum amount to be paid out per year will be \$60,000.
- E. Any state delegate to the State Convention who is being compensated for the State Convention by State or National funds shall not receive state delegate pay.
- F. All state delegate checks will be mailed by July 31.
- G. All state delegates must preregister by submitting the registration form that will be printed in the convention issue of the state newspaper and on the North Carolina website.
- H. Verification of attendance will be the responsibility of the local President or the local Delegate-at-large.
- I. Disputes will be settled by the State Board.

New TSP Options

Beginning September 15, 2019 New Options Coming To TSP!

We've discussed a few of the changes already in place with TSP, including more efficient ways of changing your password and your beneficiary.

Enhanced Security:

As of **April 15, 2019**, you've had the option to make online access to your TSP account even more secure by enabling two-step authentication at login. This means that you'll receive a one-time verification code by email or text message each time you log into your account. To add this security feature, log into My Account on tsp.gov and go to your profile settings.

Enabling two-step authentication helps you protect your account against fraud. This login process is more secure because it means that online access to your account requires something you know (your account number or username and password) and something you have (the one-time code you receive in your email or on your phone). Someone who tries to log into your account fraudulently won't be able to gain access without the code.

Before you can use two-step authentication, you must first validate an email address or cell phone. You can validate your contact information in your My Account profile settings.

With the passage of the TSP Modernization Act (PL 115-84), new changes are coming to the TSP withdrawal options. Below are some questions and answers about how these changes might affect you, as taken from the TSP fact sheets.

If you have additional questions, please contact them through the ThriftLine at 1-877-968-3778.

***Peak ThriftLine Call Times — (January 29, 2018) Thriftline's highest call volume is on Monday and Tuesday mornings. If you want to minimize your wait time to speak to a Participant Services Representative, consider calling outside of those peak hours. Participant Service Representatives are availa-

ble Monday through Friday, 7:00 a.m. to 9:00 p.m.***

When will the changes happen?

All of the new withdrawal options will go into effect September 15, 2019.

What happens between now and when the new rules take effect?

From now through September 6, you'll continue to have the same withdrawal options available before the law passed. For details, see the TSP booklet that applies to your situation: *Withdrawing Your TSP Account After Leaving Federal Service or In-Service Withdrawals.*

Starting September 15, you'll have those same withdrawal options in addition to those described in the rest of this fact sheet. TSP will update guidance in their booklets and on tsp.gov when the new options go into effect.

If you need to withdraw money before these changes take effect, TSP must receive your properly completed request by 11:59 p.m. on September 6, 2019. They will not be able to accept withdrawal requests during a brief period between September 7 and September 14. This transition period allows them to finish processing withdrawal requests received before the rules change and prepare to accept requests with the new withdrawal options.

Remember, you're only *gaining options*. TSP is not taking anything away. You may want to wait until September 15 or later to request your withdrawal so that you can take advantage of more flexibility and use new, more efficient online tools to initiate your request.

What's going to change?

Beginning September 15, 2019, you will have more options for how and when you can access money from your TSP account. These options fall into the following categories:

- After you separate from service, you can take multiple post-separation partial withdrawals.
- If you're 59¹/₂ or older and still working in federal civilian or uniformed service, you can take up to four in-service withdrawals each year.
- You'll be able to choose whether your withdrawal should come from your Roth balance, your traditional balance, or a proportional mix of both.
- You will no longer need to make a full withdrawal election after you turn 70¹/₂ and are separated from federal service. (You will still *(Continued on page 22)*

need to receive IRS required minimum distributions (RMDs).)

- If you're a separated participant, you'll be able to take monthly, quarterly, or annual payments.
 You'll be able stop, start, or make changes to your installment payments at any time.
- You'll have enhanced online tools to help you make withdrawals in the My Account section of tsp.gov. Read the following sections for more details.

Partial Withdrawals:

Right now, you're limited to one partial withdrawal in your lifetime—either an age-based in-service with-drawal (when you're 59½ or older) or a partial post-separation withdrawal.

Under the new policy:



- You'll be able to take up to four age-based inservice withdrawals per calendar year; (Current rules on the number of in-service hardship withdrawals will not change.)
- There will be no limit of the number of partial withdrawals you can take after separating from federal service (except that you won't be able to take more than one every 30 calendar days);
- You'll be able to take partial withdrawals while you're receiving post-separation installment payments.
- Having taken age-based in-service withdrawals will not prevent you from taking post-separation partial withdrawals.

Roth, Traditional, or Both:

Currently, when you take a withdrawal, the money comes from your traditional and Roth balances on a pro rata basis.

For example, if 80% of your account is in your tradi-

tional balance and 20% is in Roth, any withdrawal you take will be 80% traditional and 20% Roth.

Under the new rules, you can still use this method, but you'll also have the option to take your withdrawal only from your Roth balance or only from your traditional balance. These options will be available for all types of withdrawals.

Withdrawal Deadline:

Previously, the law required that you make a full withdrawal election once you turned $70\frac{1}{2}$ and were separated from federal service.

If you failed to do that, TSP would initiate an account "abandonment" process.

The new law does away with this requirement.

You will never be required to make a full withdrawal election, and TSP will no longer abandon accounts as they have in years past. If your account has already been abandoned, you'll be able to restore the account without making a full withdrawal election. Your restored balance can remain in the plan (subject to RMDs) with all the new withdrawal options available.

You will still need to receive IRS required minimum distributions (RMDs). You can satisfy the requirement by taking a partial withdrawal or installment payments.

If you take no action or just don't withdraw enough to meet your RMD, TSP will automatically send you the remaining RMD amount.

Installment Payments:

- Monthly payments are currently the only frequency option you have for receiving regular post-separation installment distributions from your account. The new rules will also allow you to receive payments quarterly or annually.
- Right now, if you're receiving monthly payments, you can only change the amount of those payments during an open season between October 1 and December 15. When the new withdrawal options go into effect, you'll be able to change the amount and frequency (monthly, quarterly, annual) of your installment payments—and change from life expectancy payments to a fixed dollar amount: (This is a onetime-only change. As is currently the case, once you choose to receive "dollar-amount" payments, you cannot switch to life-expectancy.)

—at any time throughout the year.

• Now, if you want to stop your monthly payments, you must receive the remainder of your account in a final withdrawal paid to you or transferred to an IRA or other eligible plan. The new rule eliminates that requirement, allowing you to stop and start your payments any time.



What will be the withdrawal process under the new rules?

At the same time as TSP rolls out the new withdrawal options, they will begin using enhanced online tools to make the withdrawal process even more efficient. Instead of just providing you with a completed paper form to send in, their new online tools will allow you to complete at least part of the transaction online.

In many cases you'll still need to provide notarized signatures or other materials in paper form. But when that happens, you'll be given only the necessary pages to complete and submit. When TSP receives those pages, they'll be able to link them to the information you've already submitted securely online and complete your transaction. This will greatly reduce the chance of errors that could cause delays, rejections, or— worse—unintended withdrawals that can't be reversed.

Can beneficiary participants use the new withdrawal options?

Yes, beneficiary participants, the spouses of deceased TSP participants who've had accounts established for them, can make all the same withdrawals as separated TSP participants.

If I've already begun receiving monthly payments from my TSP account, or elect to begin receiving payments before the new rules take effect, will the additional withdrawal options be available to me?

How about if I've already taken a partial withdrawal (either in-service or post-separation) before the changes take place? Will that prevent me from being able to take additional withdrawals later?

If you have an account balance when the new rules go into effect, even if you've begun receiving monthly payments or have taken a partial withdrawal before then, you will be able to take advantage of the new withdrawal options.

**Note that, as is currently the case, if you are receiving monthly payments and elect to make a change that affects the duration of your payments, there may be tax consequences. For more information, see the TSP tax notice: *Important Tax Information About Payments From Your TSP Account.*

Why is it taking so long to make the new options available?

It might seem like a simple thing to start allowing something that's currently not allowed, but there's a lot to be done to make these changes happen. There are substantial programming changes and form revisions to be made just to make it possible for participants to take advantage of the new options. And there are many publications and web pages that need to be changed to reflect the new policy and new procedures.

Also, as a government agency, TSP must publish any policy decisions that are necessary to implement new legislation in publicly accessible regulations. In other words, they have to publish new regulations in order to allow the new options. They also have to have a public comment period and take the time to consider comments before making final regulatory changes. TSP asked Congress for these new withdrawal options, so rest assured that they are motivated to enact them as soon as possible.

What steps does a rural carrier have to take when they are injured on the job?

First notify your postmaster or supervisor that you have been injured so the PS Form 1769, Accident Report can be completed.

Second, the Postmaster or supervisor should provide a CA-1 Federal Employees Notice of Traumatic Injury and Claim for Continuation of Pay. Complete this form and return it to management within 48 hours from the time of injury. If you are eligible for Continuation of Pay (COP) mark the box on the front of the CA-1 form for COP. To be eligible for COP you must be unable to work because of a traumatic injury. COP is the continuation of your regular pay for the first 45 calendar days you are unable to work.

We have all been told to report any injury as soon as possible. The injury must be caused by a specific event or incident or a series of events or incidents within a single work day. If you trip over a tub or tray on the workroom floor, slip on a wet floor or other surface, pick up a tray of mail and feel a pull or strain, or smash your finger with a mail box lid, you may have suffered a traumatic injury and you must report the accident immediately.

If any injury requires medical attention, you should ask for a CA-1 and a CA-16, Authorization for Examination and/or Treatment. Remember to keep a copy of the completed CA-1 for your records.

Some postmaster and supervisors have no idea what steps must be taken when a carrier is injured on the job. Reporting the injury, requesting a CA-1 and CA-16, and getting medical care are just the first steps.

I want to advise any member who is injured on the job to contact Devin Cassidy, Director of Workers Compensation at the National Office—703-684-5545. Devin can advise you and assist you with any issues arising when filing a worker's compensation claim.

If management fails to give you a CA-1 or CA-16,

contact the steward assigned to your office or area.

CAMERAS ARE EVERYWHERE

This is just a reminder for all rural carriers. There are cameras everywhere—doorbells, security cameras in trees, on porches, and the neighbor's house across the street or next door.

Everything you do is being recorded. It is very hard to defend our actions when a parcel is damaged and the video shows the carrier throwing the parcel on the porch from the sidewalk or out of the POV window.

It is very hard to defend our actions when a parked car is hit by a POV or LLV or the mail box knocked down and the carrier keeps on driving when the video shows the incident from start to finish.

BE CAREFUL!!! Remember if we do our jobs the way it should be done, videos will never be a problem. Follow the rules and pay attention to details. It is our responsibility to do the right thing.

WEINGARTEN RIGHTS

In 1975 the United States Supreme Court in the case of *NLRB v. J. Weingarten, Inc.* 420 U.S. 251 (1975) upheld a National Labor Relations Board (NLRB) decision that employees have a right to union representation at investigatory interviews. These rights have become known as the **Weingarten Rights**.

During an investigatory interview, the Supreme Court ruled that the following rules apply:

Rule 1: The employee must make a clear request for union representation before or during the interview. The employee cannot be punished for making this request.

Rule 2: After the employee makes the request, the employer must choose from among three options:

- grant the request and delay questioning until the union representative arrives and (prior to the interview continuing) the representative has a chance to consult privately with the employee;
- deny the request and end the interview immediately; or
- give the employee a clear choice between having the interview without representation, or ending the interview.

Rule 3: If the employer denies the request for union representation, and continues to ask questions, it commits an unfair labor practice and the employee has a right to refuse to answer. The employer may not discipline the employee for such a refusal.

Filing A Grievance

Stewards receive calls quite often from carriers stating "I want to file a grievance". Many times stewards receive grievances from carriers that are not properly filled out. Sometimes carriers fill out them form and leave it on the manager's desk, asking the steward 30 days later what is the status of my grievance which the steward was unaware of.

When a carrier wants to file a grievance they need to complete lines one through four on PS Form 8191. This is a postal service form and should be made available to you from your manager, but do not count on it.

You can print the PS Form 8191 off the national website. You must have a formal meeting with your manager to discuss your issue. If you are unable to resolve the issue you will advise your manager that you are filing a grievance.

Ask you manager to initial the 8191 at 3B on the date of the discussion and 3C on being timely. Allow the manager to make a copy of the grievance and give the original to the steward assigned to your office. Also include a written statement (not a novel) to the steward stating why you believe you have a grievance and the facts as you see them.

Weingarten Rights

Before any interview with management simply say

"If this discussion could in any way lead to my being disciplined or terminated, or affect my personal working conditions, I respectfully request that my union steward be present at this meeting. Until my representative arrives, I choose not to participate in this discussion. Timeliness in filing a grievance is important. You must file a grievance within 14 calendar days on any issue the carrier defines as a dispute, difference, disagreement or complaint between the parties related to wages, hours, and conditions of employment. Contact your local steward or the steward assigned to your office with any questions on filing a grievance.

Article 15 of our National Agreement provides guidelines for filing a grievance.

Number 3A on the grievance form is the date of incident. It is very important to have the discussion with your manager within 14 days of the incident which is documented with the manager's initials in number 3B. If you have questions on the date of the incident, especially with discipline issued or pay issues, please contact your local or assigned steward.

Questions:

- 1. I am on the Relief Day Work List but I am projected to exceed 2240 hours for the guarantee period which ends on October 11, 2019. As of PP 13/2019 I have worked 236.64 DACA 5 hours. My manager is not scheduling me to work my relief day if I insist on being paid a DACA 5 rate of pay. Can I file a grievance?
- A. Yes you can file a grievance. Success in the grievance process could be limited by language found in Article 8.5.C. The employer is not required to work any regular carrier on a relief day if it would cause the carrier to exceed the hours of the annual guarantee year.
- 2. I am planning on attending the National Convention in August. I have submitted my leave slip (PS Form 3971) requesting leave without pay (LWOP) for August 13 through 16, 2019. My manager states he will not approve LWOP but I must use annual leave. Is this correct?
- A. No. Article 24.2 states employees will be granted annual leave or leave without pay at the election of the employee to attend National, State and Area Union Conventions. If your manager can approve annual leave then the should approve LWOP.
- 3. I received a Letter of Warning for an at fault accident on June 3, 2019. The accident occurred on May 20, 2019. When filing a grievance what would be the date of the incident (3A on the grievance form)? My manager stated the grievance was untimely when I attempted to discuss it because the accident was over 14 days ago.
- A. The date of incident would be June 3, 2019; the date you received the discipline (letter of warning).

President Gibbs, State Officers, National Director of Steward Operations Knapp, Delegates, Members and Guests: The following is my report of my duties for fiscal year 2018-2019.

Financial Report: A copy of the Statement of Activities will be distributed and explained to those in attendance at the State Convention.

Membership: Our membership continues to grow. On June 30, 2016 we had 4958 members. In June 2017 we had 5210 members. Last year we had 5467 members. This year as of June 8, 2019 we have 5526 members.

The delegate strength for the National Convention uses the State membership total as of June 30, 2019. With our current numbers, still subject to change, we will have 56 delegates to the National convention this year.

As of June 8, 2019 our current membership totals are: regular carriers 2728; PTFs 48; relief carriers 1856; and 107 ARCs. There are 777 retired members as of this report. We also have 10 associate members. The total membership stands at 5526.

I have processed 1007 membership forms in this fiscal year with 32 of those being regular carriers. We had 37 members that passed away this year. There were 24 regular carriers that canceled their membership and 25 regular carrier members that have separated from the US Postal Service. We also had 601 RCA members and 42 ARC members that have left the US Postal Service during this past fiscal year.

Thank you to all of you, our Members, Academy Trainers, Stewards and our State Officers for your efforts in recruiting new members.

RAFT: Recruit A Friend Today (RAFT), the recruitment program implemented by the National Office was changed two years ago. The National Office no longer sent a check to the recruiter of new members. They did however, still provide an incentive payment to the state. All states were encouraged by the National Office to create their own incentive program. The past two years North Carolina had a RAFT Recruiter Raffle every quarter with a prize of \$250.00. The final drawing for this year will be on September 30, 2019. The National Office has announced that they will be returning to the former incentive program and will again send checks directly to recruiters.

North Carolina currently has 2922 non-members in our ranks. That number is down from last year when we had 3675 nonmembers. We have done a great job at recruiting this year. There are 1255 regular carriers, 29 PTFs, 1121 RCAs and 517 ARCs that are not members of the union. We all must continue to work on recruiting these non-members in our offices all across the state. Our union is only as strong as its members. Please encourage all carriers to join the NCRLCA.

Department of Labor: As a recognized labor union, one of the biggest challenges of the NCRLCA is to deal with matters of law that apply to the NCRLCA and all of its subordinate units. It is the responsibility of the Secretary/Treasurer to comply with these laws by submitting in a timely fashion all required Department of Labor Law reports.

The LM 2, which is the financial report from the state to the Department of Labor (DOL), was prepared at the close of our fiscal year and submitted to DOL in September 2019. Also, all 40 of our districts are required to submit a LM 4 report to the DOL within 90 days of the close of the fiscal year. All 40 reports were done by me as the administrator for the districts. Copies were sent to each district secretary to keep with their district records.

DOL website.

IRS and NC Department of Revenue: It is the responsibility of the Secretary/Treasurer to submit bi-weekly all taxes withheld from employee paychecks to the IRS and NC Department of Revenue. Annual and Quarterly reports are required to be submitted to each. The annual 940 report to the IRS was submitted before the deadline. The CPA firm of Sherrill, Blake and Harrison prepare these reports each quarter. They also do an annual audit of all our financial records. This annual financial report cannot be completed until after the close of the fiscal year on June 30, 2019 and will be included in a later issue of the North Carolina Rural Carrier

Travel and Meetings: I attended the National Convention in Grand Rapids, MI in August, SAC in Atlanta, GA in January, our State Convention in Atlantic Beach, The Dwyer Homecoming party in January, all State Board Meetings, three Realignment Committee meetings, two State Delegate Committee meetings, seven District meetings, and 22 new hire orientations. I have driven 6993 miles on association business. I had 19 overnight stays where the NCRLCA paid for my hotel. I also had 4 overnights for National Secretary/Treasurer training in Alexandria, VA in March that were paid for by the National Office.

Personal Note of Thanks: I want to thank you, the members, for allowing me to be your North Carolina Secretary/Treasurer. I truly enjoy working for you.

I also would like to thank all of our Stewards; from the local Steward all the way up to our District Representatives, for all that you do. You have a difficult and unappreciated job. Steward Annual Reports Mid Carolina District

This report covers my union activity from July 1, 2018 through June 21, 2019.

During the last 12 months, I have attended 175 PDIs (Pre-Disciplinary Interviews) and processed 144 grievances. Step 1 grievances included 13 Contractual grievances, 12 Letters of Warning, 6 7-Day Suspensions, 6 14-Day Suspensions, 2 emergency placements and 2 removals. At Step 2 I settled 79 contractual grievances, 3 LOWs, 3 14-Day Suspensions, 11 emergency placements, and 7 removals. Twenty grievances were appealed to Step 3—10 removals and 13 contractual grievances. Currently there are three Notices of Removal awaiting Area Arbitration.

I attended National Convention in Grand Rapids, Michigan in August 2018. I attended the NC State Convention in Raleigh, SC State Convention in Charleston, the Fall Rally in Lexington, SC and SAC in Atlanta. I attended 11 District Meetings across Mid Carolina, 2 Labor Management meetings with the Mid Carolina District Manager, and 5 Labor Management meetings at different post offices throughout the year. During this time, I attended 8 Formula Implementation Standup Talks and 5 USPS/NRLCA Safety Initiative Meetings in Charlotte. This year I conducted 6 Local Steward Training Classes with the help of the Assistant District Representatives in Asheville, Shelby, Concord, and Wallace and 2 Area/ADR/DR training classes. I attended Regional Steward Training in the Fall and District Representative Training in the Spring in Alexandria, Virginia. Along with Ronnie Stutts, Dennis Conley, Bethany Small, Kelly Kenny-Futch, and Jeanette Dwyer, I visited the areas of Kinston, New Bern and Wilmington meeting with carriers following Hurricane Florence seeing first hand the destruction caused by this violent storm.

I attended the National Convention in Grand Rapids, Michigan in August 2019. I attended the Fall Regional Seminar in Alexandria, VA in October 2018. In October 2018, I attended a district meeting in Greenville, NC for District #51 (Tar River) and one in November of 2018 in Whiteville, NC for District #8 (Southeastern). I attended the South Atlantic Conference in January 2019. In April and May of 2019, I attended 6 district meetings (#51 Tar River in Greenville, #56 Wayne Co. in Goldsboro, #52 Tidewater in Jacksonville, #32 Harnett Co. in Dunn, #8 Southeastern in Elizabethtown, #23 Sea Level in Wilmington). I attended 5 USPS/NRLCA Safety Initiative Meetings in Charlotte NC and I continue to serve as an NRLCA representative for the District Safety Team.

I drove 18,396 miles in this period (9,898 in 2018 and 8,498 thus far in 2019) with 10,376 miles driven in my POV and 8,020 miles driven in Rental Cars. I rented vehicles for 41 days and I stayed overnight on 14 occasions.

During the last 12 months, I attended 103 Pre-Disciplinary Interviews and I processed 101 grievances. Out of the 101 grievances, 70 were Contractual, 20 were Disciplinary and there were 11 Class Actions. There were 83 sustained or settled at Step 1, 3 settled at Step 2, 2 settled at Step 3, with 12 pending adjudication and 1 was withdrawn. Out of the 20 Disciplinary Grievances, there were 8 Letters of Warning, 5 7-Day Suspensions, 3 Emergency Placements and 4 Removals.

I would like to thank the NCRLCA State Board for their continued support and I would like to thank District Representative Sally Corriher for her patience and guidance that she shows to all of the Stewards in the Mid-Carolinas district. I would like to thank Executive Committeeman Dennis Conley and the entire NRLCA National Board for their faith in me as a Steward, the support they provide to the Steward System and for their service to the Rural Craft. I would like to thank the Assistant District Representatives, the Area Stewards and the Local stewards that I have had the pleasure to work with. I would like to thank the
