I would like to say **THANK YOU** to all the family members that came out and were active with the Auxiliary. We had **twenty-five** juniors in attendance.

We have two juniors running for Junior National Office, Anakin Hamlet for Secretary/Treasurer and

Lily Gray as Executive Committeemen. It has been several years since any junior from North Carolina has run for a National Office. North Carolina stand and support our Juniors!

As you all are aware, we were back in DC to visit Congress. It was productive and they were willing to listen. H.R. 4268, The Federal Retirement Fairness Act (what we call RCA buy back) has sixty cosponsors, however, only three NC Representatives have signed on. Congresswomen Ross, Manning, and Adams have co-sponsored this bill. Please email or call your Representative to ask them to sign on. The Senate still has no companion bill. Please notify Senators Tillis and Burr to help write a companion bill.

We also urged them to pass H.R. 3287/S. 1663, the USPS Shipping Equity Act which will allow the Postal Service to ship alcoholic beverages. We already have signature capture capabilities, and we deliver to every house every day. Adult signature would insure no one under the age 21 will be able to sign. This could bring millions of dollars to the Postal Service. This bill would not overturn any state or local laws, it will only give us the right to deliver. Again, please ask your Representative and Senator to cosponsor this bill.

Do not forget that we should start seeing our pay raise on August 5, pp 16-2022. However, back pay will be at a later date.

Thank you to all the offices that participated in the Food Drive in May. The Food Bank appreciated all of your support

2022 Legislative Seminar

Audrey and I started setting appointments with all the North Carolina Representatives and Senators about a month before our visits in Washington DC. We continued to follow up with the Representatives right up to the days prior to meeting with us.

They still have tightened security and with Covid-19 protocols still in place, we allowed them to choose how they wanted to meet with us. The inperson meetings required us to go thru security tighter than TSA. We also had to be escorted in and out of the buildings with an Aide.

Paul Swartz and the Legislative Committee began with a first-timers meeting. There were quite a few of us. Paul Swartz, Director of Governmental Affairs, started out with the introduction of Legislative Issues. Jim Slaughter went through Parliamentary Procedures and Roberts Rules of Order.

After lunch, National President Ronnie Stutts did a national presentation, and Secretary/Treasurer Clifford Dailing went over Recruitment, Raft, LM reports and Election, followed by more training on Legislative Issues and on Financial Audits with Rich Mozier, NRLCA Controller.

Brad Fitch, President & CEO, CMF gave a presentation on how to have a successful meeting. Jessica Brady, Senior Director, Distilled Spirits Council, Tammy Whitcombe, Inspector General, USPS OIG, and CQ Deputy Editor, Jason Dick spoke on Legislative Agenda.

Cameron Deml, Director of Insurance Programs went over the new Medicare Integration with a PowerPoint program.

The Legislative Committee took us through more Officer training and Paul Swartz did a final review of the issues we would be speaking with the Senators and Congressmen/women in the days ahead, for the House and Senate Resolutions that have been proposed and which Senator or Congressman/woman has cosponsored them. They distributed "Fact Sheets" for us to hand to the Representatives or their Aides to further their knowledge on the issues we were requesting their support on.

The seminar was full of information on our roles as officers and preparing us for our Capitol visits. That night, that's when my nerves kicked in. "*What have I got myself into?*", that was my thought.

We were on the Hill for the next two days meeting with each Representative or Senator's Legislative Aides. We received a lot of positive responses back from them.

We were able to Zoom meet with Kathy Manning of Dist. 6. She was on a committee assignment the week we were in Washington D.C. We did thank her for her support in co-sponsoring H.R. 4268. Currently, Rep. Manning and Rep. Ross from Dist. 2 are the only two in North Carolina that have cosponsored. If you are in one of those Districts please thank them for their support.

I had talked to people who have gone to Washington D.C. before and took their advice to wear good shoes, prepare to do a lot of walking and you will learn to be a lobbyist for the Postal Service. The experience was wonderful, and I learned a lot. I must say Van Heath and Audrey are very well versed and I'm taking in everything. I thank both for all the feedback they have given me.

Now it's your turn. We **NEED YOU** to write or call your Representative and Senator and ask for their support. It took 14 years for H.R. 3076, the Postal Service Reform Act to get passed!

Let's work together to get the next two passed sooner. We need to work as one to make our voice heard and make us a stronger Union for tomorrow. Safety

Be Seen to Be Safe

We know as we serve our routes how dangerous the traffic can be. There are steps we can take to make our jobs safer. Signs and lights are a good way to make our vehicles more visible. Proper maintenance and daily inspection of our route vehicles insure they are in proper working order. Proper alignment of mirrors ensure that you can see a threat, and hopefully avoid it, before it causes an issue.

Those who drive postal owned vehicles don't have to worry as much about the visibility of their vehicles. The size and shape of the vehicle along with the paint and safety lights make them easily recognizable. For us POV drivers, it's not so simple. With many different styles and shapes of vehicles that we use, we aren't as easily recognizable. Magnetic signs and flashing amber lights make us stand out and while signs aren't necessarily required by law, amber warning lights are. N.C. General Statute § 20-130.2. "Use of amber lights on certain vehicles; limited use" states that mail delivery vehicles "shall be equipped with an amber-colored flashing light which shall be so mounted and located as to be clearly visible in all directions from a distance of 500 feet, which light shall be activated" when performing their duties.

Our vehicles work best when they are properly maintained. Postal owned vehicles should be inspected daily at the appointed time using Notice 76, Expanded Vehicle Safety check. Report any issues to your supervisor immediately and submit a Form 4565, Vehicle Repair Tag. This is your documentation that you've reported any issue with the vehicle and puts it on management to get it fixed.

For POV drivers, your vehicle should be checked prior to reporting for work. It should be maintained to Notice 76 standards and have a valid state inspection, registration, and liability insurance.

Before you depart for your route, you should ensure that all mirrors on your vehicle are properly aligned. Use a mirror station to help adjust mirrors on postal owned vehicles, if needed. POV drivers need to take care when loading to ensure visibility out of your windows. Safety should be your number one concern, even if management's insistence on getting back on time makes you question THEIR priorities.

I know the vast majority of us do this properly every day we work, but it bears repeating. Every one of us wants to go home in the same condition we reported to work. Working in a safe manner is a part of the job. Make it a part of your daily routine.

What If I Did Nothing?



Sometimes there is so much information, it's hard to decide what choice to make so we do nothing.

When it comes to retirement planning from the postal service, doing nothing will accomplish more today than it would have in 1987.

TSP began in April of 1987 with just one fund the G Fund. In January of 1988, the C and F Funds were added to the mix of investments. We had to wait until May of 2001 to have more funds added; the S and I Funds were introduced at that time. The most recent change in available investments came in July 2005 when the L Funds (retirement date targeted) were introduced.

Rural carriers had to enroll to have contributions go into one of the funds, until automatic enrollment began August 1, 2010. The postal service automatically contributed 1% into the G fund once carriers were enrolled.

As of October 1, 2020, new career employees (PTF or Regular) are automatically enrolled in the TSP with a 5% deduction from their gross pay being

deposited into the age-appropriate Lifecycle (L) Fund, unless they make another choice or choose not to participate.

Employees hired before then either contribute automatically at 3% or do not have any automatic contributions and had/have to opt-in to TSP. Their contribution levels did not change when the newer rules were implemented.

The Postal Service says that employees throw away nearly \$200,000,000 per year in retirement benefits by failing to contribute enough to receive the full amount of the 5% matching funds. It is never too early or too late to start planning on those golden years.

No matter what amount you decided to contribute, what fund(s) you put in your investment, or when you started contributing. Being proactive will bring better results than doing nothing.

To the non-career carriers (ARC/RCA), you can start investing now with your own individual retirement account (IRA) with a private company. Even though they are not matching funds, 5% of your check bi-weekly will have plenty of time to grow before you reach retirement age.

So with the changes in when you make career status and with how much is being matched, there really isn't a way to tell everyone what they will have at retirement **if they did nothing.**

The Impact of Postal Reform

First off, I would like to take a moment to say what a great convention we had. It was a very exciting atmosphere with a record number of forty five first timers in attendance! I am so thankful you attended, participated, and learned the business process of your organization. As our district assignments change yearly, I won't see some of you that I encouraged to attend, So **THANK YOU** for coming out and as for the others I look forward to seeing you again as district meetings crank back up!

I have written a couple articles on the Postal Service Reform Act (PSRA) and new information is starting to trickle down. As promised, I am trying to keep all of you updated. This will be a two-part article so tune in next issue for the rest of the story.

NRLCA President Ronnie Stutts touched on this at our state convention, and I want to go more in depth on PSRA.

There are three primary drivers of health benefits change in the PSRA:

- 1) Postal Risk Pool
- 2) Medicare Integration
- 3) Mandatory Medicare

The PSRA will establish a Postal service Risk Pool, mandates Medicare, and the key dates are *April* 2024 and January 1, 2025, and there is nothing for Rural Carriers to do at this time.

There are **two** requirements for keeping your health insurance into retirement and those are retiring on an immediate annuity and be enrolled in FEHB program for **five years before retiring**.

There is no special enrollment form to complete, and your premium is deducted from your retirement benefit. There are also **two** requirements for maintaining health coverage for surviving spouses. You must elect a Survivor Annuity Benefit and be enrolled in Self Plus One or Family coverage when the retiree dies. The premium is deducted from your Survivor Benefit Annuity. I also want to add that you MUST maintain NRLCA membership for the Rural Carrier Benefit Plan.

What does this mean for the RCBP? There are three main parts to the PSRA. Postal Service Only Risk Pool or Postal Service Health Benefits program, Medicare integration, and **mandatory** Medicare Part B. The technical effective date is January 1, 2025, and OPM still needs to issue guidance.

Postal reform creates a postal service risk pool **NOT** a new plan! Currently the FEHB program is the risk pool for federal and postal employees, retirees, and annuitants.

*RCBP, GEHA, Blue Cross are all plans in this "pool"

For example:

- 1. RCBP will **ONLY** participate in PSHB (we only cover rural carriers and their dependents)
- 2. BCBS Standard would have to be available for FEHB (all Federal Workers) and PSHB (only postal workers and retirees)
- 3. Plan benefits must be nearly identical
- 4. Premiums could be different and possible lower for PSHB

In the next issue, I will go in depth on the Medicare portion of the Postal Service Reform Act.

Thank you for your support and patience as all this information is evolving.

Way back in late May our State President Audrey Solomon, State Vice-President Elaine Althoff and myself attended the NRLCA Legislative Conference in Washington DC at the Hyatt Regency. That is a good location for such a conference. The hotel is located about one block from the White House and two to three blocks from the Capitol as well as the Congressional and Senatorial Office Buildings. That puts almost everywhere we need to be within walking distance.

Now that we have finally gotten Postal Reform passed, we can move on to other items that we wish to work on.

The first of these new items is HR 3287/S 1663, the United States Postal Service Shipping Equity Act. Introduced in House (05/17/2021)

United States Postal Service Shipping Equity Act

This bill authorizes the mailing of alcoholic beverages by certain entities in accordance with the delivery requirements otherwise applicable to a privately carried shipment. The authorization applies to an entity (including a winery, brewery, beverage distilled spirits plant, or other wholesaler, distributer, importer, or retailer of alcoholic beverages) that has registered with, obtained a permit from, or obtained approval of an application from the Department of the Treasury.

The bill directs the U.S. Postal Service (USPS) to prescribe regulations (1) requiring direct delivery to a duly authorized agent at a postal facility or to the addressee, who must be at least 21 years of age and present a valid, government-issued photo identification at the time of delivery; (2) prohibiting such alcoholic beverages from being for resale or any other commercial purpose; and (3) requiring such entity to certify that the mailing is not in violation of applicable laws or regulations and to provide other information as directed by the USPS.

The fact that the USPS is not already permitted to

deliver alcoholic beverages is a holdover from the days of Prohibition. Prohibition; the 18th Amendment to the US Constitution was passed into law in 1920. It was repealed in 1933. The fact that this law still determines what can or cannot be shipped by the USPS is an unfair restraint on the USPS as it is legal for private delivery companies such as UPS and FedEx to do so.

Our second bill is the one everyone has been waiting for, Introduced in House (06/30/2021).

The Federal Retirement Fairness Act

This bill modifies the federal civilian service that is creditable service under the Federal Employees Retirement System (FERS).

Specifically, it expands the nondeduction service that may be creditable under FERS. Nondeduction service is federal service where an employee's pay is not subject to retirement deductions (e.g., service under a temporary appointment such as RCA).

Currently, nondeduction service performed before January 1, 1989, is creditable under FERS so long as a deposit is made into the retirement fund to cover the period of nondeduction service.

This bill allows nondeduction service performed on or after January 1, 1989, to be creditable under FERS so long as a deposit is made into the retirement fund.

You will find the HR-4268 Form Letter at the bottom of the PAC LEGISLATIVE page at NCRLCA.ORG. Copy the letter, tell your member of congress how many years of nondeduction service that you have. Adding a personal story will go a long way with members of Congress. Mail your letter!

Signing up for PAC Withholding from your Paycheck

Active carriers may elect to use one of their three payroll allotments to donate every two weeks. You must sign up for withholding exclusively through PostalEASE.

Have readily available **your 8-digit Employee ID Number** (on your paycheck stub) and your **4-digit USPS PIN or password.** If you don't have your USPS PIN you will need to call PostalEASE at: 877-477-3273. Press #1 for PostalEASE. When prompted, enter your employee identification number. When prompted for your pin, pause, and then press #2. Your PIN will be mailed to your address on the next business day.

Steps for signing up Online:

- 1. Add your Employee I.D. number to the end of the 9-digit NRLCA-PAC Account (163055555) to create your PostalEASE account number.
- 2. Now you are ready to log into: liteblue.usps.gov.

Steps for signing up by Phone:

- 5. When prompted, choose option #2 to select Payroll Allotments.
- 6. When prompted, choose option #1 to select type of Allotment. When prompted, press "2" to continue.
- 1. When prompted, press "3" to continue to 'ADD' the allotment.
- 2. When prompted, add routing number: 051400549.
- 3. When prompted, add the NRLCA-PAC account # followed by your Employee ID Number. It should look like: **163055555**______. No hyphens, no spaces, 17 digits total. If correct, Press "1."
- 4. When prompted, press "1" for checking.



Factors in Auto Insurance

Hello Everyone!

I hope you are all having a great summer!

I know everything is crazy expensive right now, so it might be the perfect time for you to call National General and get a quote on your insurance. I know we are all trying to pinch every penny we can and this may be a great cost saver for you and your family!

Below I have listed things that affect your rate. There are many factors involved and hopefully this will help you understand your rates better. Factors That Affect Your Rate

Many factors are used to determine what you pay for insurance. Below is a list and description of some of the more common factors we use. However, not all of these factors are allowed in all states. For example, in California, we cannot use "financial responsibility" in setting your rate, and in Pennsylvania and North Carolina, we cannot use "gender" in setting your rate.

Your driving history: The fewer traffic tickets and accidents you have, the less you'll pay for auto insurance. Statistics show that drivers with no traffic violations or accidents have a lower chance of being involved in an incident that could be expensive for the insurance company. That's why these drivers get lower rates.

Your vehicle: You'll probably pay higher collision and comprehensive premiums if you own a vehicle that is expensive to repair, causes more damage to other vehicles in an accident, or is more likely to be stolen. Because sports cars and SUVs typically fall into these categories, they generally cost more to insure.

Where you live: Statistics show that drivers in small towns have fewer auto accidents than those living in large cities. So if you live in a small town, you'll probably pay less for car insurance. If you live in an area where natural disasters, severe weather, theft or vandalism are more likely to occur, you'll probably pay more for auto insurance.

Age: If you're under age 25, you'll pay more for auto insurance. If you're between 50 and 65, you'll generally get the lowest rates. Why? Because statistics show that drivers under age 25 have more accidents than older drivers, and drivers between 50 and 65 usually have the lowest accident rates.

Marital status: Statistics show that married drivers have fewer accidents than single drivers. So, if you're married you'll probably pay lower auto insurance premiums. This particularly applies to younger drivers.

have included a copy of our financial report that was presented to the delegates. It is on pages 33-35. This is not the final report for the year. Our fiscal year ends on June 30th and our finances will be audited by CPA firm Blake & Sherrill at the close of the year. If you have any questions please give me a call. A final report will be available after the financial audit has been completed.

We had four Constitution changes presented to the body. Three of them passed and one was withdrawn.

Change #1 was to freeze the membership dues at the State level until the State's equity is brought down to \$750,000. We currently have \$1,567,234. in equity. This passed.

Change #2 was withdrawn by the maker.

Change #3 was to add a PAC co-chair to help with the PAC duties. This passed.

Change #4 was to allow the President and Vice President to seek a third term in office under extenuating circumstances such as what we just experienced with Covid-19. This passed.

The updated Constitution can be found on our website under the "State Info" tab. A link to the PDF is at the top of that page right before the State Officer listings.

We had one resolution before the body. This resolution addressed the South Atlantic Conference (SAC). It proposed that the SAC board attempt to locate a different facility in which to hold the SAC meeting. It also proposed an increase in the SAC membership fee for each state to be \$2000. SAC fees are currently \$500 for each state. This passed.

A second resolution was brought up in new business. It addressed the awarding of routes for RCAs. After some debate this resolution failed.

Our Hall of Fame inductees this year were Owen Moore and Leonard Scronce. Mr. Moore is a former State President and was the original creator of this newsletter in 1985. He served as the editor for ten years. He was also instrumental in the creation of the "L Route". President Solomon will be visiting Mr. Moore to present him with this award.

Leonard Scronce served as our State Secretary from 1962-1976. He also served as the National Chaplain. He has passed and his family will receive this award.

I want to say thank you to everyone that made this Convention a success. Thank you to all the "Old Timers" for making all the new people feel welcome. Thank you to all of you that brought and shared your knowledge with our membership.

Like I said before, I hope you learned something and I hope you enjoyed yourself in the process.

This report covers my activities as Vice President from November 13, 2021, through May 21, 2022.

In November I attended the State Convention in Greensboro, NC. Immediately following the adjournment of our State Convention, I attended the board meeting and met with both newly elected and re-elected board members to receive our assignments and duties. I also attended the State Board Meetings for Officer training in February that was held in Cherokee, NC. In May I attended the Legislative Seminar in Washington DC.

In April I attended Spring District Meetings for District 20 Sandhills (Cumberland/Hoke) in Fayetteville; District 54 Union in Monroe; District 50 Piedmont in Salisbury and District 57 in Banner Elk.

I covered 7 Orientations in Asheville, NC for new hire recruitment and attended 4 District meetings, not including my own district meeting. I traveled 2,598 miles, and used a total of 6 Annual Leave days, 13 Leave without paydays, and 8 overnight stays during this time.

Thank you for allowing me to be part of this great union's journey.

Secretary Treasurer Vicki Gray

First of all, I want to commend everyone for the hard work you are doing. I know it has been a very stressful year and that providing the "service" in the United States Postal Service has been challenging. Thanks for hanging in there!

I am sadden by the loses we have endured these last two years. I hope you and your family are all are safe and healthy.

The following is my report of my duties during fiscal year 2021-2022.

Membership: Our membership as of June 1, 2022 stands at 4918. On June 8, 2019 we had a high total of 5526 members. We had 5376 on June 20, 2020. We had 5355 members on June 15th last year.

As you can see, our membership numbers are down compared to the last few years. As of June 1, 2022 our current membership consists of 2725 regular carriers; 67 PTFs; 1328 relief carriers; and 60 ARCs. There are 738 retired members as of this report. We also have 4 associate members. The total membership is 4918.

I have processed 734 new membership forms this fiscal year. 18 of those were regular carriers. Out of these 734 new members, 251 of them were RCAs or ARCs that have already separated from the Post Office.

From our membership, we had 70 regular carriers and 623 relief carriers separate from the US Postal Service this fiscal year. These numbers do not include any carriers that were not members.

We had 57 members pass away this year.

There were 26 regular carriers that canceled their membership this year.

Non Members: North Carolina currently has 2713 non-members in our ranks. There are 1248 regular carriers, 33 PTFs, 1113 RCAs and 319 ARCs that are not members of the union.

I want to remind you that National has reinstated the **Recruit A Friend Today (RAFT)** incentive

program. You will receive \$15 for each RCA or ARC that you recruit and \$50 for each regular carrier or PTF that joins. There is no longer a waiting period. You will receive the incentive payment immediately after the 1187 dues withholding form is processed.

Please encourage **all** carriers to join the NCRLCA. We need members. We have strength in numbers

Department of Labor: As a recognized labor union, one of the biggest challenges of the NCRLCA is to deal with matters of law that apply to the NCRLCA and all of its subordinate units. It is the responsibility of the Secretary/Treasurer to comply with these laws by submitting in a timely fashion all required Department of Labor Law reports.

The LM 2, which is the financial report from the state to the Department of Labor (DOL), was prepared at the close of our fiscal year and submitted to the DOL in September. Also, all of our local districts are required to submit a LM 4 report to the DOL within 90 days of the close of the fiscal year. All 31 reports were done by me as the administrator for the districts. Copies were sent to each district secretary to keep with their district records.

All of these reports are of public record and can be seen on the DOL website.

IRS and NC Department of Revenue: It is the responsibility of the Secretary/Treasurer to submit biweekly all taxes withheld from employee paychecks to the IRS and NC Department of Revenue. Annual and Quarterly reports are required to be submitted to each also. All reports were submitted on time as required.

I also have to file the 990's for the State and all local districts to maintain our non-profit status. These are due in November every year. All 990's were filed prior to the due date.

Travel and Meetings: This year I have gone to 34 new hire orientation classes, mostly in Fayetteville, but occasionally in Charlotte and Raleigh for the purpose of recruiting new members to our ranks. I attended two in person Board Meetings along with several teleconference or Zoom meetings. I attended our condensed State Convention in November. I went to

seven local Spring District Meetings.

I have driven 4844 miles on association business. I had nine overnight stays this year.

Financial Report: The CPA firm of Sherrill, Blake and Harrison will be auditing the books at the close of our fiscal year, June 30, 2022. A complete financial report will be printed in an upcoming issue of the *North Carolina Rural Carrier* after that audit has been completed. Please feel free to call me if you have any questions regarding our finances.

Thank you: I want to thank all of our Stewards; from the local Steward to our District Representatives for all that you do. Thank you to the Academy Instructors that assist in the recruitment of new hires. Thanks also to the State Board for their support.

Special thanks to my husband and my family.

Lastly I want to thank you, the members, for allowing me to serve as your North Carolina Secretary/Treasurer. It has been my honor and privilege to work for you again this year.

State President Solomon, all members of the State Board and all members of the NCRLCA, and guests, this is the report of your Legislative Representative for the 2021-2022 year.

Inasmuch as the Fall District Meetings were cancelled, I attended no meetings in the Fall of 2021. I did attend the State Convention held in Greensboro. Those present did not see as much of me there as I would have liked as I was also attending the State School Board Conference being held simultaneously at the same venue.

This spring I attended District Meetings in Smithfield, Fayetteville, Lumberton, Durham, Sanford, Murfreesboro, New Bern, Rocky Mount, Oxford, and my home district meeting in Williamston. I would like to thank all of the districts for their hospitality.

I also attended the Annual Legislative Conference in Washington DC.

At this point, it removes the onus of the \$5 Billion per year payment from the Postal Service to pre-fund health benefits for retirees seventy-five years out. It will also move us out of the FEHBP into the Postal Service only Postal Service Health Benefit Program. We should not see any changes in our health coverage. Lastly, the bill; beginning in 2025, will require all new retirees to enroll in Medicare Part B. The overwhelming majority of us already do, so that is not a major issue.

It was an honour and a privilege to serve again as your Legislative Rep.

Recording Your Break

Our State Convention last month in Cherokee was a great success. It was wonderful to see everyone who was able to make it and we welcomed forty five firsttime attendees!

The Stewards challenged the State Board to a bowling match to raise money for PAC and while the Stewards were not victorious in our bowling endeavor, the group managed to raise \$540 for PAC. Everyone seemed to enjoy themselves, and I hope that we will be able to do something similar at our future conventions.

NRLCA President Ronnie Stutts was the keynote speaker and he spent most of his time discussing RRECS and the newly ratified National Agreement. President Stutts' time at the podium was insightful, informative and eye opening for us

all. He, along with NRO Dennis Conley and NRO Jeanette Dwyer also took as many questions as they could in the hopes of addressing all the concerns raised by those in attendance. It is a privilege to be able to hear directly from the source when learning about all the changes that the rural craft is facing.

The Steward presentation went very well in my opinion. ADRs Jeff Essick, Eddie Moss, Gail Naillon, Kelly Futch, Ralph Fernandez and I presented on a variety of topics, and we also answered questions submitted by attendees. Some of the topics included the formula, leave policies, forced breaks, workplace environment, and how to file a grievance.

The Steward system is also looking for carriers to join us as Local Stewards. If you have ever considered becoming the Steward in your office, please reach out to any ADR and we will help you with the election process and answer any questions that you have.

One of the topics that was brought up repeatedly at the convention was Carriers being required to take, and if not take, then to record, a break. Article 30.1.F.1 states 'Rural carrier craft employees may stop for not more than thirty (30) minutes for lunch. If carriers stop for lunch, the exact time used must be recorded.' Article 30.1.F.2 states 'Lunch may be taken in segments of less than thirty (30) minutes, at the carrier's option, provided the time taken does not exceed thirty (30) minutes. Segments may be taken in the office or on the route, provided the normal schedule is maintained to the extent possible. The parties agree that the lunch time taken by the carrier is not compensable.' The intentional use of the word 'MAY' and the phrase 'at the carrier's option' by the parties means that it is the exclusive choice of the CARRIER whether to use (up to 30 minutes) for a break period. The parties were also explicitly clear that if a break period (of any duration) is taken, it is to be accurately recorded on the 4240.

Let me be crystal clear, you are NOT REQUIRED

TO TAKE A BREAK under our national agreement. You are also not required to record a period as a break that you did not take! Conversely, if you are taking breaks that you are not recording, you must immediately start accurately recording these on your 4240. Below is an excerpt from an email

(redacted for protection of sources) I recently sent to district leadership:

I am getting reports out of many offices that Carriers are being required to take a minimum of a 10-minute lunch. Whereas before the carriers were being threatened with it, now management is actually doing it.

Per the ELM 665.44: Falsification in Recording Time: Recording the time for another employee constitutes falsification of a report.

Per the PO 603 Section 12.f :Basic Carrier Responsibilities: Completing PS Form 4240, Rural Carrier Trip Report, daily to accurately reflect actual hours and minutes worked each day. Any deviation from the official route mileage, and/or the reasons for any delay, must be explained under the remarks section of the form.

PO 603 Section 411.2: Use of the PS Form 4240: Recording Lunch Break: At this time, also record in column 6, in ink, the total lunch time. If no lunch time was used, leave this column blank.

While I understand that it may be necessary from time to time to amend an entry that is incorrect or missed, it should not be the policy of our managers to intentionally violate the EL 902, the ELM or the PO 603. This kind of behavior is not tolerated for Rural Carriers, and it certainly should not be tolerated for our managers. Managers are supposed to lead, they are supposed to set an example for the employees in the office. I doubt that falsifying time records would be looked at as behavior that we want employees to emulate. When management conducts themselves in this manner, not only does it harm the employee by underpaying them, but it also undercuts and erodes any remaining trust between staff and leadership. I recall just a few short years ago that there was a district in Virginia where management ranks were thinned as a result of on OIG investigation on changing time keeping. Why are we seeing this here in NC? Do our managers understand that this is a Federal Crime, a Felony, an act that is punishable by fines and jail time?

We tell our carriers that there are only 2 circumstances under which they can refuse a direct order from management: when the order is unsafe or when the order is illegal. Requiring carriers to falsify their 4240 and record a lunch that was not taken or otherwise make inaccurate entries on a 4240 by an employee is not only a violation of the PO 603, but it is also illegal. Management changing 4240 entries is a violation of the ELM, it is contrary to employee responsibilities and expectations

Local Stewards

Procedure to File a Grievance

(See Example PS Form 8191 on next page)

You fill out the sections with red dots (# 1 - 4, except 3b & 3c). Management fills out the sections with the blue dots (#3b & 3c) when <u>you</u> actually file (discuss the issue) the grievance with them. (THIS DISCUSSION MUST BE WITHIN 14 DAYS FROM THE DATE IN 3a).

Once you have filed, let management make themselves a copy and you must get the original to the steward or representative immediately. The steward or representative **only has 10 days** from the date in 3b to setup a meeting with management.

Include a signed and dated statement telling your side of the issue. This statement is for the steward only. Management will not see your statement.

Never hesitate to call your steward or representative with questions if you need assistance. Never put your entire statement in #4 on the grievance form (PS Form 8191). Just state the issue in the form of a single question. Then, provide the steward with a statement explaining your side of the issue.

NOTE: Just filling out a grievance (PS Form 8191) and sending it to the steward or representative is NOT filing a grievance. You must discuss the issue with management at the time you are filing the grievance and follow the proper procedure.

Management must fill out sections 3b & 3c.


