


STATE CONVENTION KEYNOTE SPEAKER

Beat the Heat

Woodland Hills, CA Rural carrier Peggy Frank, age 63, was found dead in her mail truck July 6, 2018, according to news reports. The cause of death was later determined to be from heat. The temperatures that day were elevated, and she was

driving an LLV (no A/C for the POV drivers). Heat is a very real and deadly threat we all face as rural carriers and unfortunately Peggy was not the first carrier to suffer this fate. It is important that we take all the precautions we can to protect ourselves.

Prevention is the best way to keep yourself safe from the summer heat. Proper hydration is easy and effective. Replace electrolytes as well as fluids by drinking equal amounts of water and a sports drink like Gatorade throughout the day, starting before you leave the office. Wear light-colored, loose-fitting clothing and avoid sugary or caffeinated beverages. Drink fluids regularly all day.

It is important to know the signs of heat exhaustion and heat stroke. Early action gives you the best chance at recovering from heat related illness.

Both of these conditions can be deadly, and treatment is relatively the same for both of these conditions. Immediate action is required.

- ▶ Move to a cool/shaded area
- ▶ Drink cool (not cold) liquids
- ► Alert supervisor or emergency services ASAP
- ► Cool compresses under arms and on forehead
- ► Loosen tight clothing

If you notice you have stopped sweating, **ACT IMMEDIATELY!**

Call 911 and pull over, as you are in danger of losing consciousness if you can't lower your body temperature. If you can contact a supervisor, they should be able to track your scanner in case you pass out.

Please keep yourselves hydrated and safe this summer.

TSP Updates



Having access to your investments is important to ensuring your retirement plan is working.

Recently I received an email from TSP telling me they are making changes to the types of accounts options we will have available to us. But in order to do that, they will have to shut down our access for a short period of time. When this article is published there will be a couple of weeks before it happens. Please be prepared if you are trying to take out a loan against your TSP or need to make a significant withdrawal.

Expected transition dates

May 16 to the first week of June

All transactions temporarily unavailable May 26 to the first week of June

Full access and transactions restored First week of June

Here is what I received in my email

Dear Participant:

In order to add exciting new features to your TSP we're transitioning experience, administrative services to a new service provider later this year. You need to know how this transition might affect you, especially if you were planning to request a transaction soon. Be sure to visit our website to see key transition dates when we'll need to temporarily suspend certain transactions and services. Planned downtime like this is typical of major, complex processes, and you may remember a similar situation when we added flexible withdrawal options in 2019.

We expect to complete the transition the first week of June. You'll still have access to the same low-cost TSP funds, account management tools, and participant services you enjoy now. You'll also be able to use new features that give you more choices, more layers of security, and more efficient ways to manage your retirement income with us.

Important transition dates you need to know

You can find a list of transition dates on our website, which vary by transaction or service.

Some key transactions will be temporarily unavailable beginning Monday, May 16.

These include submitting a request for a loan, withdrawal, or distribution from your TSP account. All transactions and services, including My Account and the ThriftLine, will be temporarily unavailable after Thursday, May 26, and until the first week of June, when the transition period ends.

Your investments during the transition

Rest assured that during this transition period, your money will remain invested in the TSP funds you've chosen. There will be a short period—beginning at noon eastern time on Thursday, May 26, and ending the first week of June—when we'll need to suspend changes to TSP investments.

This means that your TSP investments will still be subject to market gains and losses during this brief period, and you won't be able to make changes until after the transition to the new service provider.

Accessing your account after the transition

When the transition period ends the first week of June, you'll have several options for accessing and managing your TSP account. Your main source for account details and transaction requests continues to be My Account—with a new look and feel, new tools, and more ways to connect with us through live chat and virtual assistance. You'll also be able to download an official TSP Mobile App with the option to use your device biometrics, such as fingerprint or facial recognition, to secure and access your account. When our mobile app becomes available, we'll post links on our website so you can be confident about downloading the one that's from the TSP.

When you access your account for the first time after the transition, you'll need to set up new login credentials. Step-by-step prompts will make it simple for you to verify your identity, update your contact information, and set up your account security. Every TSP participant will need to go through this setup process whether or not you've set up online access previously. Setting up this access is critical to ensuring that you receive TSP communications about your account and account transactions.

Where to find more information

As the transition period gets closer, we'll be updating our website with more details about these new features and other changes. These updates will include a specific date for the end of the transition period and any dates that might shift.

New Contract & Postal Reform

It has been a very active year for our Union and the Postal Service. We have a new contract and on April 6, 2022 Postal Reform was signed into law.

These are great accomplishments and that also means change. As things progress there will be many changes and updates related to the Postal Service Reform Act (PSRA). As Cameron Deml, Director of NRLCA Insurance Programs said, "There is not enough space to address every issue, every question, and every situation".

I will keep all of you updated as information becomes available. I want to remind everyone that all this information is new to me as well. Also, my door is always open to assist ALL of you, just remember that I am a working carrier and have a 46k route. Please leave me a voicemail or text if I do not answer and I will return your call.

Postal Reform is made up of three primary components in terms of health plans and benefits:

- ♣ Postal-Only Risk Pool or Postal Service Health Benefits Program
- * Medicare Integration
- * Mandatory Medicare Part B, Part B special enrollment, and penalty waiver

Work is already taking place and the initial effective date for the PSHB is January 1, 2025.

If you are 65, retired, and have Medicare Part B, you do not need to do anything at this point.

For the rest I have assembled and borrowed some Q&A scenarios.

Q: What is the "Pre-Funding Mandate" and how does it impact the Postal Service?

A: The Postal Accountability and Enhancement Act (PAEA) of 2006 required that the Postal Service "prefund" 100 percent of its retiree health benefit liabilities, 75 years into the future, at a cost of \$5.5 billion a year over the first ten years. The USPS now "owes" the government over \$35 billion of the unpaid portion of this legal obligation. The draconian prefunding mandate is a large reason why the Postal Service slowed service and curtailed hours of plants, operation. closed processing subcontracting, and severely reduced staffing. It also hurt the Postal Service's financial ability to upgrade buildings and infrastructure, and purchase a new vehicle fleet

Q: How does "Medicare Integration" work?

A: With Medicare Integration future retirees, when Medicare eligible at age 65, will remain in the Federal Employee Health Benefit Program (FEHBP) in retirement. They will also be required to be enrolled in Medicare Parts A and B. Retiree health coverage will then become a combination of Medicare and FEHBP. The provisions of Medicare Integration will become effective on January 1, 2025.

Q: If I am already retired will this obligation apply to me?

A: No. Medicare Integration will be applied only on a prospective basis However, if a current postal retiree over age 65 with FEHBP who has not already joined Medicare B and now wishes to join will have a one-time opportunity to do so and have the "late enrollment" penalty waived.

Q: Will current and retired employees remain in FEHBP?

A: Yes. The pending legislation keeps all postal workers in the Federal Employee Benefits Health Program. All workers will be able to keep their current plans and avail themselves of the annual open season if workers wish to choose other options within FEHBP.

Q: If I am retired but have not reached the Medicare Eligibility age of 65, will I have to enroll in Medicare Parts A and B to maintain my health insurance?

A: NO

Q: Under this proposed bill, if I am an active USPS employee and currently under the age of 65,

will I be required to have Medicare Parts A and B when I retire from USPS?

A: Yes. Medicare Integration means enrolling in Medicare Parts A and B when you turn 65 in order to maintain your FEHBP coverage. However, if you are at least 64 as of January 1, 2025, this would not apply to you.

Q: Will this pending legislation affect my prescription drug costs?

A: Yes. The Postal Reform Act allows the various FEHBP plans to take advantage of special Medicare D discounts for postal workers that many private employers use. These discounts lower the cost of prescription drugs to the recipients.

National Delegate Election by Secret Ballot

This year the National Convention will be held in Orlando, Florida from September 6-9, 2022.

A secret ballot election for the delegates of the North Carolina RLCA to the 2022 NRLCA National Convention will be conducted by mail.

The deadline for delegate nominations has closed.

Ballots will be mailed to members between May 21 and May 26, 2022.

Any eligible member who does not receive a ballot or whom spoils a ballot may request a new ballot by contacting the Election Committee Chairperson, Debra Bennett at 910-436-6487. If you request and return another ballot, only the replacement ballot will be counted.

Counting of the National Delegate ballots will take place on Saturday June 18, 2022 beginning at 10:00 AM at Harrah's Resort, at 777 Casino Drive, in Cherokee, NC 28719.

Any candidate or designee may observe the ballot tabulation.

National Delegate Ballots

Your ballot will be in your hands very shortly. Ballots will be mailed by May 26, 2022.

Please do not throw it in the trash. Take the few minutes it will take you to open it and vote. These people are going to be representing you. They are your voice. Don't be silent.

Encourage your coworkers to vote too.

The delegates that are selected (by your votes!) will be shaping the future of our union. They will be voting, up or down, for the changes our National Board will seek and fight for in contract negotiations with the United States Postal Service.

Every person on that ballot is interested in shaping that future. They are counting on your votes. It is very disheartening to realize that your fellow coworkers do not bother to take the few minutes it would cost them to complete and return that ballot. It is very obvious that most of our members do not bother. North Carolina normally gets back between 10 - 12 percent of the ballots that are mailed out. That is very sad. The union spends a lot of time and money to see that every member has the chance to be heard

State Convention

The State Convention will be held at Harrah's Resort & Casino at 777 Casino Drive, Cherokee, NC 28719 on June 19 thru June 22, 2022 with the business session starting on Monday June 20. Complete address and reservation information for the State Convention can be found on the back page of this issue.

Elections for the positions of President, Vice-President (one year term), Secretary/Treasurer (two year term) and Executive Committeeman (three year term) will be conducted on Wednesday June 22, 2022.

Included below are the rules for State delegates from the *North Carolina RLCA constitution*, Article VI.

Section 3. State Delegates.

- A. All districts shall be entitled to one delegate vote for each six paid-up members or a fraction thereof.
- B. No delegate shall represent more than one district.
- C. No district shall be represented in the State Convention by proxy.
- D. The total delegates from a district (if not in full attendance) may be voted by the one or more delegates in attendance.

and roughly 88% throw that opportunity away.

Our delegates are using their annual leave and/or LWOP to take the time to attend the National Convention. Yes, they get some money from the union to go, but that allowance does not come close to covering their expenses.

I have also heard it said that this is a vacation paid for by the union. Let me assure you, it is no vacation. Delegates are required to be in attendance for all sessions of the Convention, from Tuesday morning until the adjournment on Friday. That is all day, every day from 8:00 am—5:00 pm, sometimes even later. Delegates are also required to be in Caucus on Thursday evening. Caucus starts at six and often goes until ten, eleven or even later! I'm sure this year will be a very long Caucus night.

It is definitely not a vacation. It is a lot of work packed into a few days. It can be an exhausting experience; but it is a very rewarding one!

Every person on that ballot wants to be a part of that. They are asking you to give them the opportunity to serve you and our union as a national delegate. **PLEASE VOTE!**

Besides all the convention events there are several fun, free and interesting things to do in Cherokee.

In Cherokee you can enjoy many outdoor activities. There are hiking trails and rock climbing. You can visit swimming holes and waterfalls.

Go kayaking, tubing, or whitewater rafting on the rivers.

There are even several elk that can be spotted grazing in the fields near the Oconaluftee Visitor Center on Highway 441. You may see them on your drive in!

Another fun & free thing to do is search for the painted bears that are all over the town. In an effort to highlight Tribal artists, several Eastern Band of Cherokee artists have created a series of large, lifelike fiberglass bears and painted them in bright vibrant colors and designs. Bears are a large part of the Cherokee culture. According to Cherokee legend, black bears are the keepers of dreams. They are placed throughout the streets of Cherokee. There are currently 19 bears completed. 25 bears have been commissioned. Each is a work of art. There is one at Harrah's resort.

To learn about the history and culture of the Cherokee people visit one of these spots.

* "Unto These Hills": is one of the most popular things to do in Cherokee. You'll be moved and transported back in time as you watch the story of the Cherokees unfold before your eyes. This is an outdoor drama. There is a preshow at 7:30 p.m. and the show starts at 8:00 p.m. nightly, except Sundays.

FYI ~ Driving to the State Convention

Most GPS systems will send you to Cherokee from I-40 via Highway 19. This route is shorter mileage wise but it is a narrow, winding road through the mountains. It is a beautiful, scenic route and will get you to Cherokee just fine, just at a much slower pace.

You can also get to Cherokee via Hwy 74/ Hwy 23/Great Smoky Mountain Expressway and then take Hwy 441 North into Cherokee (do not take Exit 103 to Maggie Valley & Cherokee – stay on US 74 until Exit 74 onto Hwy 441N) This way is a little longer in miles but is a nice wide road and has a higher speed limit. It is still a pretty a ride but is definitely not as narrow & winding as Highway 19.

Make sure you park and check-in at the Cherokee Convention Center and not the at the original Harrah's Resort. The Cherokee Center has a separate entrance with it's own parking garage. If you park in in the original facility you will have a long walk to your room and the convention.

State Convention Preregistration

Appearing below is Article VI, Section 4 from the Constitution of the North Carolina Rural Letter Carriers' Association. This language was adopted at the 2019 State Convention in Raleigh.

This is the procedure put in place for our members to be compensated (paid) for attending the state convention as delegates.

Members must also be **elected to serve as delegates at the local meeting**; as per Article IV.

This complies with labor laws which require that delegates must be elected by a direct vote of the membership.

Mail the completely filled out and signed preregistration form to me. Please print clearly as an illegible registration may cause it to be to deemed unacceptable.

You must preregister to be eligible to receive payment as a delegate.

Forms may be copied and will also be available on the website www.NCRLCA.org.

Please send in as early as possible.

ARTICLE VI, Section 4 State Delegate Compensation

- A. State delegates shall be compensated up to \$100.00 per each completed business session day of attendance at the State Convention for expenses.
- B. The state shall set aside a total amount equal to the rate of .00017% of a 40 hour, Step C, Table 1 regular rural carrier's yearly pay for each member on the rolls on June 30, to be used to pay state delegates. (proviso first deposit will be July 2019)
- C. These funds shall be held in an interest-bearing account.
- D. The maximum amount to be paid out per year will be \$60,000.
- E. Any state delegate to the State Convention who is being compensated for the State Convention by State or National funds shall not receive state delegate pay.
- F. All state delegate checks will be mailed by July 31 or within 30 days of the close of the State Convention if delayed.

GUIDELINES FOR SELECTION OF OUTSTANDING MEMBER OF THE YEAR

I. Method of Selection

- 1. Nomination of candidates for the award shall be made prior to the State Convention. Nominations may be made directly from the members inviting such nominations. Also, local, county or district units may select candidates for the award.
- 2. In either event, the name of the candidate should be submitted, with a brief resume of accomplishments, to a Selection Committee to be named by the State Board, or by any other means, which may be the prevailing policy in the State Association.

II. Eligibility for Award

- 1. Any MEMBER of the Association may be nominated as a candidate for the Outstanding Member of the Year Award.
- 2. State Association Officers should not be arbitrarily selected for the award nor should they be eliminated from consideration. Officers have been chosen to lead and serve, but it is frequently demonstrated that their services go far beyond the routine duties of the office and, thus may be worthy of selection.

III. Criteria for Selection

- 1. The primary consideration of the Selection Committee shall be:
- (a) The service rendered by the candidate to the Rural Letter Carriers' Association;
- (b) Attendance and participation in local, state and national meetings;
- (c) Willingness to accept responsibilities and dedication in performing those duties;
- (d) Fraternal Attitude to others of the Rural Carrier Craft.
- 2. The Selection Committee should also consider, as a secondary matter, other service which the candidate may have rendered, such as civic and community activities, which reflect favorably upon the Rural Letter Carrier Craft and the Postal Service.
- 3. Consideration shall be given for services rendered in the immediately preceding twelve-month period, but not completely limited to this period of time. New carriers

should be encouraged to seek to achieve this award.

IV. Presentation of Award

When each State Association has made its selection, the name of the candidate shall be reported to the

National Office by the State Secretary on the regular Annual Report. An appropriate award will be presented by the National Rural Letter Carriers' Association at its National Convention.

V. Other

These guidelines are not intended to be binding and a State may use any other selection procedure that is suitable for each State.

The announcement of the recipient of the award will be made at the banquet at the State Convention. The State Secretary shall report the name to the National Office and the award will be presented at the National Convention with State presentation at the Fall Booster.

This year the State Board has appointed the immediate past three recipients of the award to serve as the Selection Committee.

Signed, Sealed, & Delivered Postal Reform

In the last issue I wrote that Postal Reform had passed in the House 342-92 and had been sent to the Senate. Majority Leader Schumer intended to fast track the bill and get it to the President. It did not happen that way. It only takes one objection and fast track ends. It took several weeks to get the bill onto the agenda and then there were Senators that objected to the new postal transportation contract. There was an insistence that Postal Vehicles be electric. That went on for a few days, some sort of settlement was reached and finally the Senate passed Postal Reform 79 to 19. Both NC Senators voted in the affirmative. The bill was sent back to the House where no changes were made and forwarded to the President on March 28th where it sat for nine days. On April 6th 2022, President Biden signed Postal Reform becoming Public Law 117-108.

I just signed the Postal Service Reform Act of 2022 into law – setting the Postal Service on more stable financial footing and creating a more modern, accountable service for tomorrow.

And with one stroke of a pen sixteen years of hard work by many members of Congress, the Postal Service, all of the Postal Unions and all of us, Postal Reform has been enacted.

Many of the bills that did not pass would have drastically increased what Postal Workers and Retirees paid for healthcare.

This legislation was different.

First, no one will see decreased benefits. The Postal Reform Service Act of 2022 creates a new Postal Service Health Benefits (PSHB) program for all USPS employees and retirees; benefits will mirror those offered through the Federal Employees Health Benefits (FEHB) program. Cost for coverage for postal employees and retirees are expected to stay the same or even drop because of savings from integration with Medicare.

Second, the legislation upholds promises to retirees. While postal employees will need to enroll in Medicare Part B <u>after retirement</u>, current retirees will not be required to do so.

In addition, the Postal Service Reform Act ensures mail delivery will continue six days per week, a service fundamental to the USPS's core mission.

This bill also relieves the Postal Service of the burdensome prepayment of retiree health benefits. That is the \$5 billion dollar per year debt that the Congress levied upon the Postal Service in the 2006 bill. That is gone.

PAC Works!

On Wednesday April 6, 2022, President Biden signed the Postal Service Reform Act into law. This is the first overhaul of the Postal Service in over a decade. This legislation repeals the requirement by the Postal Service to prefund its retirees' health benefits decades in advance. Your PAC dollars worked toward making this happen!

We now must be vigilant and contact our representatives asking for their support of H.R. 4268, the Federal Retirement Fairness Act. This bill would allow nondeduction service (service that is performed by a noncareer employee) on or after January 1, 1989, to be creditable under FERS providing a deposit is made into the retirement fund.

This legislation has NO COSPONSORS in our state. On June 30, 2021, it was referred to the House Committee on Oversight and Reform. We have one member that is on that committee. She is Virginia Foxx and is the Representative for the 5th District.

Now for North Carolina PAC news!! North Carolina ranked third in the year-to-date aggregate totals with over \$12,000.

Signing up for PAC Withholding from your Paycheck

Active carriers may elect to use one of their three payroll allotments to donate every two weeks. You must sign up for withholding exclusively through PostalEASE.


Have readily available **your 8-digit Employee ID Number** (on your paycheck stub) and your **4-digit USPS PIN or password.** If you don't have your USPS PIN you will need to call PostalEASE at: 877-477-3273. Press #1 for PostalEASE. When prompted, enter your employee identification number. When prompted for your pin, pause, and then press #2. Your PIN will be mailed to your address on the next business day.

Steps for signing up Online:

- 1. Add your Employee I.D. number to the end of the 9-digit NRLCA-PAC Account (163055555) to create your PostalEASE account number.
- 2. Now you are ready to log into: liteblue.usps.gov.
- 3. Enter your employee I.D. number and password, then click "log on."
- 4. Click on "PostalEASE."
- 5. Click on "I Agree."
- 6. Enter your Employee I.D. and password again and log in.
- 7. Click on "Allotments/Payroll NTB."
- 8. Click on "Continue."
- 9. Click on "Allotments."
- 10. Enter the following Financial Institution routing number: **051400549**
- 11. Enter your NRLCA account number, followed by your Employee I.D.#:163055555_____, (No hyphens, No breaks, 17 digits total).
- 12. Enter account type as "Checking."
- 13. Enter the amount you want to be taken out **every two [2] weeks** not the amount you want to give yearly.
- 14. Click on "Validate."
- 15. Click on "Submit."
- 16. Click on "print page" to see and print your confirmation number for your records.

Steps for signing up by Phone:

- 1. Dial 1-877-477-3273 (1-877-4PS-EASE).
- 2. Press "1" for PostalEASE.
- 3. When prompted, enter your Employee ID Number.
- 4. When prompted, enter your USPS Pin Number.
- 5. When prompted, choose option #2 to select Payroll Allotments.
- 6. When prompted, choose option #1 to select type of Allotment. When prompted, press "2" to continue.
- 1. When prompted, press "3" to continue to 'ADD' the allotment.
- 2. When prompted, add routing number: 051400549.
- 3. When prompted, add the NRLCA-PAC account # followed by your Employee ID Number. It should look like: **163055555_____**. No hyphens, no spaces, 17 digits total. If correct, Press "1."
- 4. When prompted, press "1" for checking.
- 5. When prompted for the dollar amount of the allotment, enter the amount of your choice to be deducted bi-weekly (per pay period) using the \$ 00 format. Press "1" if correct.
- 6. When prompted, press "1" to process.
- 7. Record the confirmation number given for your records and note the date the first allotment will take place. Press "1" to repeat, or press "9" to hang up.



The Zoom Link will be posted on the state website (NCRLCA.ORG) prior to the meeting date.

There will be training sessions scheduled for the mini-mail count that will be coming up in the fall – look for details in the next edition of this magazine.

Procedure to File a Grievance

(See Example PS Form 8191 on next page)

You fill out the sections with red dots (# 1 - 4, except 3b & 3c). Management fills out the sections with the blue dots (#3b & 3c) when **you** actually file (discuss the issue) the grievance with them. (THIS DISCUSSION MUST BE WITHIN 14 DAYS FROM THE DATE IN 3a).

Once you have filed, let management make themselves a copy and you must get the original to the steward or representative immediately. The steward or representative **only has 10 days** from the date in 3b to setup a meeting with management.

Include a signed and dated statement telling your side of the issue. This statement is for the steward only. Management will not see your statement.

Never hesitate to call your steward or representative with questions if you need assistance. Never put your entire statement in #4 on the grievance form (PS Form 8191). <u>Just state the issue in the form of a single question</u>. Then, provide the steward with a statement explaining your side of the issue.

NOTE: Just filling out a grievance (PS Form 8191) and sending it to the steward or representative is NOT filing a grievance. You must discuss the issue with management at the time you are filing the grievance and follow the proper procedure.

Management must fill out sections 3b & 3c.
