Heat & Hydration

Summer is Coming (Again)!

Yes, that time is coming yet again when management is regularly giving stand up talks on heat safety and how to avoid heat illness. I usually write about it every year about this time so I'm fairly certain we all know the dangers of heat exposure in what we do.

Despite the number of times we hear about heat illness, it does bear repeating as it has the potential to be fatal.

Knowing the signs of heat illness is the first step in prevention.

Here is some information provided in Postal Bulletin 22646 from March 21, 2024.

Here are some proactive tips to help beat the heat:

- Hydrate before, during, and after work.
 Prevention is important drink at least 8 ounces of water every 20 minutes.
- Dress appropriately for the weather. On warm days, wear light-colored, loose-fitting, and breathable clothing to keep your body temperature down.
- Use the shade to stay cool. When possible, use shaded areas to stay out of direct sunlight.

This time of year also brings our State Convention. Many of you hopefully attended your District meetings in preparation. We have put a lot of effort into planning what we hope you will find is a fun and informative Convention.

On our speakers list is a State Trooper from the North Carolina State Highway Patrol to speak on safety issues and laws that are important for us in our daily duties.

Signs of Heat Illness

- Hot, dry skin or profuse sweating;
- Headaches;
- Confusion or dizziness
- Nausea or vomiting
- Rapid pulse
- Muscle cramps
- Weakness or fatigue
- Rashes.

If an employee experiences signs of heat-related illness, they must seek immediate medical assistance by calling 9-1-1.



Survivor Benefits

Information for Survivors and Loved Ones

The worst day ever is not something anyone puts on the calendar as they would a vacation or retirement. But those left behind will still need guidance to receive what they are entitled. The information provided below will help guide you or them through the process of reporting the death of a federal employee or retiree and applying for any potential death benefits that may be payable.

How to report the death of a Federal Employee or Retiree

To report a death, you can do one of the following:

- Complete an online Report of Death form. (OPM.gov/retirement)
- Call the Retirement Information Office at 888-767-6738 at 888-767-6738, Monday through Friday during the hours of 7:40 am and 5:00 pm EST/EDT.

What you need to report:

- Retiree/employee's name.
- Any information you may have, such as the retiree/ employee's date of birth, social security number, claim number and address.
- Names and addresses of the survivors so that we may send out information regarding potential death benefits that might be payable.

If this is the death of a current federal employee, please contact the employing agency and report the death directly to them as well.

After reporting the death

Retirees

Once OPM is notified, the office will create a claim number for the deceased and send a packet to the survivors that includes:

• Application for Death Benefits (Standard Form 3104 for FERS, Standard Form 2800 for CSRS) with a return pink envelope.

Retirement

• FE 6 – OFEGLI <u>Claim for Death Benefits</u> with a return blue envelope. If you have questions, or need help completing this form, call OFEGLI at 1-800-633-4542. Their Customer Service Center is open Monday through Friday, 8:30 a.m. to 4:00 p.m. EST/EDT.

Employees

If the deceased was an employee, the employing agency at the time of death will provide the survivors with an information packet and work with them to provide OPM with the necessary information.

Documents to include with your Application for Death Benefits

To process an Application for Death Benefits, OPM must receive certain documents from the applicant. Providing these documents with your application will help to prevent delays in processing your application. In addition to a complete application, you should submit the following:

- Proof of death that shows the date and cause/ manner of death. We cannot accept a pending death certificate.
- Proof of termination of any marriage. Submit a copy of final divorce, annulment, or death certificate with your application.
- If you are the widow/widower, include a copy of your marriage certificate.
- If you are a child of the deceased, include a copy of your birth certificate showing both of your parents' names.
- If you are a court-appointed administrator, executor or other official of the estate of the deceased, include a copy of the appointment with a raised seal.

After submitting your application

Once OPM has received a complete application, the claim will be assigned to a specialist for processing in the order in which it was received. If the claim involves the death of an employee, it will be assigned to a specialist once OPM has received the death package from the employing agency and payroll office. If additional information is needed to process the claim, the specialist will reach out directly to the survivor(s) and/or agency. Once the specialist has all documentation needed, they will process the claim accordingly.

If I'm eligible, how will I receive my payment?

On your application for death benefits, there is a section that asks you how you would like to receive your payment. If you are receiving a one-time lump sum benefit, payment may be sent via hard copy check or direct deposit. If you are receiving a monthly benefit, the Department of Treasury requires that federal payments be sent via electronic funds transfer (EFT). There are only three exemptions that would allow for a paper check: if the recipient is over 90 years old, if the recipient lives more than 50 miles from an ATM, or if recipients are unable to manage their own finances.

Types of Survivor Benefits that may be payable by OPM

Monthly Annuity

A monthly annuity may be payable to a current spouse, former spouse (if a retiree elects this benefit or if it is awarded by court order), a minor child, disabled dependent and/or student. Creditable service and length of marriage requirements must also be met.

REMINDER

Membership in the NRLCA terminates upon retirement.

Retirees must reenroll to remain a member of the union.

You must keep your membership active if you have the Rural Carrier's Benefit Plan Heath Insurance.

Please complete PS Form 1187 R to remain a member.

Contact Vicki Gray at (910)745-8815 to have an enrollment form mailed to you.

Lump-Sum Credit

If there is not and will not be anyone eligible for a monthly survivor annuity, a lump-sum of any remaining retirement deductions may be payable. If an annuitant has exhausted all their retirement deductions, accrued annuity for the number of days they lived in the month they passed (minus any health benefit or life insurance premiums) may be payable.

Basic Employee Death Benefit (FERS ONLY)

If an employee dies with at least 18 months of creditable service, a current spouse or former spouse (if awarded in a court order) may be entitled to the Basic Employee Death Benefit.

All this information is available on the <u>OPM.gov</u> website. It wouldn't hurt to print this off and place it with your will, insurance policies and other important documents. It will be challenging enough for those left behind to deal with the passing, do something to lighten their stress.

NATIONAL CONVENTION

National Delegate Election by Secret Ballot

This year the National Convention will be held in Reno, Nevada from August 27-30, 2024.

A secret ballot election for the delegates of the North Carolina RLCA to the 2024 NRLCA National Convention will be conducted by mail.

The deadline for delegate nominations has closed for this year.

Ballots will be mailed to members between May 17 and May 23, 2024.

Counting of the National Delegate ballots will take place on Saturday June 15, 2024 beginning at 10:00 AM at Great Wolf Lodge in Concord, NC.

Any candidate or designee may observe the ballot tabulation.

In reporting the results of the election, the candidates shall be placed on the roster in the order of votes received. The number of delegates to which the state is entitled shall be declared regular



delegates; the remaining candidates shall be declared alternates.

In the case of a tie vote, the tie will be broken with a blind drawing done by the Election Committee.

Didn't Receive Your Ballot

Any eligible member who does not receive a ballot or whom spoils a ballot may request a new ballot by contacting the Election Committee Chairperson, Debra Bennett at 910-436-6487. If you request and return another ballot, only the replacement ballot will be counted.

National Rural Letter Carriers' Association Director of Labor Relations Bridget Boseak

Bridget Boseak, of Mayville, Michigan, is currently serving the NRLCA in her second term as the Director of Labor Relations, directing and overseeing the grievance and arbitration process and labor relations issues with the USPS.

Prior to serving on the National Board, she served ten years as Regional Representative and twelve years serving the Michigan Rural Letter Carriers' Association as State Steward. She also served the Michigan Rural Letter Carriers' Association at every level of the steward program, as well as county secretary for Lapeer County RLCA, for a combined total of more than 30 years, beginning just six months after being hired as an RCA in the Lapeer Michigan Post Office in 1990.

Prior to being assigned as Regional Representative, Bridget was serving the NRLCA as a member of Task Force 1, developing resource materials and training for stewards. She also served as a member of the Appeal Review Committee, which revised Appeal Process at the National Convention. Bridget served on the committee to create the Appeals Commission. She also served 3 years on the Resolutions Committee at the National Convention, including chairing that committee in 2000. Bridget served on the Appeals Committee for four years including chairing that committee.

- C. No district shall be represented in the State Convention by proxy.
- D. The total delegates from a district (if not in full attendance) may be voted by the one or more delegates in attendance.

Appearing below is Article VI, Section 4 from the Constitution of the North Carolina Rural Letter Carriers' Association. This language was adopted at the 2019 State Convention in Raleigh.

This is the procedure put in place for our members to be compensated (paid) for attending the state convention as delegates.

Members must also be elected to serve as delegates at the local meeting; as per Article IV.

ARTICLE VI, Section 4 State Delegate Compensation

Every member of the NCRLCA will receive a ballot with a list of names of members that wish to be your delegates to the National Convention.

One of your rights as a union member is to vote for the people you want to represent you at the National Convention. Less than 10 percent of our members take the time to fill out their ballot and mail it back. Let's change that this year!



GUIDELINES FOR SELECTION OF OUTSTANDING MEMBER OF THE YEAR

I. Method of Selection

- 1. Nomination of candidates for the award shall be made prior to the State Convention. Nominations may be made directly from the members inviting such nominations. Also, local, county or district units may select candidates for the award.
- 2. In either event, the name of the candidate should be submitted, with a brief resume of accomplishments, to a Selection Committee to be named by the State Board, or by any other means, which may be the prevailing policy in the State Association.

II. Eligibility for Award

- 1. Any MEMBER of the Association may be nominated as a candidate for the Outstanding Member of the Year Award.
- 2. State Association Officers should not be arbitrarily selected for the award nor should they be eliminated from consideration. Officers have been chosen to lead and serve, but it is frequently demonstrated that their services go far beyond the routine duties of the office and, thus may be worthy of selection.

III. Criteria for Selection

- 1. The primary consideration of the Selection Committee shall be:
- (a) The service rendered by the candidate to the Rural Letter Carriers' Association;
- (b) Attendance and participation in local, state and national meetings;
- (c) Willingness to accept responsibilities and dedication in performing those duties;
- (d) Fraternal Attitude to others of the Rural Carrier Craft.
- 2. The Selection Committee should also consider, as a secondary matter, other service which the candidate may have rendered, such as civic and community activities, which reflect favorably upon the Rural Letter Carrier Craft and the Postal Service.
- 3. Consideration shall be given for services rendered in the immediately preceding twelve-month period, but not completely limited to this period of time. New carriers

should be encouraged to seek to achieve this award.

IV. Presentation of Award

When each State Association has made its selection, the name of the candidate shall be reported to the

National Office by the State Secretary on the regular Annual Report. An appropriate award will be presented by the National Rural Letter Carriers' Association at its National Convention.

V. Other

These guidelines are not intended to be binding and a State may use any other selection procedure that is suitable for each State.

The announcement of the recipient of the award will be made at the banquet at the State Convention. The State Secretary shall report the name to the National Office and the award will be presented at the National Convention with State presentation at the Fall Booster.

This year the State Board has appointed the immediate past three recipients of the award to serve as the Selection Committee.

I'm Just a Bill Sitting Here On Capitol Hill

As President Audrey Solomon and I prepare for our meetings on Capitol Hill April 27th-May 1st I would like to remind you that you too can do your part in helping not only us but all crafts by writing your congressman/woman... urging their support on the following issues:

► H.R 5995, The Federal Retirement Fairness

Has 89 co-sponsors and Congresswoman Kathy Manning Dist. 6 is the only NC co-sponsor; so send her a *Thank You* for her support. To you this is better known as "The Buy Back Bill".

Most Rural Letter Carriers start out as part-time employees, on average it takes 6 to 7 years to become career employees Pre 1989 part-time service was eligible for buy-back credit. (This is based on days you worked not years worked and will help many rural carriers retire and this should save the Postal Service money as we are on a 2 tier pay scale.)

► H.R. 3721, The United States Postal Service Shipping Equity Act

18 co-sponsors and as of 05/25/2023 and has been referred to the Committee on Oversight and Accountability, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned. (Congress.gov)

This was sent to the Oversite committee last year when we were up there.

This allows Alcoholic beverages to be considered mailable. This is a revenue generator of \$180 Million. USPS already has Adult Signature service. This is a fairness issue, UPS& FedEx deliver alcohol.

► H.R. 82, The Social Security Fairness Act

You heard Van Heath talk about this one. Repeals WEP/GOP (Windfall Elimination Provision/Government Pension Offset)

Eliminates GPO which reduces Social Security benefits for spouses, widows, and widowers who also receive government pension. Eliminates WEP which reduces Social Security benefits for individuals who also receive a pension/disability from an employer that did not withhold Social Security.

► H.R. 7629. The Protect Our Letter Carriers Act

This is relativity new it was introduced in the House on March 12, 2024, has 20 Co-Sponsors.

Protect Our Letter Carriers Act of 2024

This bill requires or authorizes certain actions related to the U.S. Postal Service (USPS).

The bill requires the Department of Justice to appoint an assistant U.S. attorney in each judicial district to coordinate and supervise the investigation and prosecution of various crimes related to postal services (for example, assault on a postal service employee, breaking into a post office, or obstruction of mails).

The bill also requires the U.S. Sentencing Commission to amend sentencing guidelines to provide that the assault or robbery of a postal employee shall be treated the same as the assault of a law enforcement officer.

Additionally, the bill authorizes appropriations for the USPS to install high security collection boxes and replace older versions of the universal mailbox key with electronic versions. (Source:Congress.gov)

The latest bill that we are following and encouraging our membership to contact their members of Congress is H.R. 7629, the "Protect Our Letter Carriers Act" H.R. 7629 appropriates \$1.4 billion to modernize the arrow key with a new electronic version, as well as review the sentencing guidelines of crimes against postal employees, and appoint an assistant U.S attorney with the responsibility of prosecuting crimes against postal employees. We have all read about the increase in crimes against Postal employees. Often these criminals are after our Arrow Keys. It is time that the Postal Service came into the 21st century and updated the equipment we all use out on our routes. There is a pre-written letter available on the NRLCA.org website on the "Legislative Updates" page under the "Legislative" tab. Since this bill was introduced, we have added several cosponsors every week. As I write this, we have twenty cosponsors, and none are from North Carolina.

We are still following and supporting several other bills in Congress. We still want to encourage everyone to write your members of Congress to ask for their support.

HR 82/S 597, The Social Security Fairness Act.

We still have the same 6 NC cosponsors for this bill, and the total cosponsors count is up to 311. Neither of our Senators have signed on for this bill. There are fifty-three cosponsors in the Senate.

The six cosponsors from NC are Representatives Adam (NC12), Ross (NC2), Manning (NC6), Davis (NC1), Jackson (NC14) and Foushee (NC4). If you are represented by one of the other members from our state, we really need you to write letters and make phone calls to make this bill happen.

HR 3721, The United States Postal Service Equity Act. This is the bill that finally repeals Prohibition in the Postal Service and would allow us to deliver alcohol just like our competition. This bill may be a lost cause. It is beyond my understanding why Congress would not give us an equal footing with our

competition. There are only eighteen cosponsors.

The "Federal Retirement Fairness Act" or the "Buy Back" bill is up to eighty-nine cosponsors. For a bill to ever have a chance of coming to the floor for a vote, it must have a minimum of 218 cosponsors.

Our biggest task now is to write and or call our members of Congress and ask that they cosponsor and vote to pass **H.R.** 5995.

The original co-sponsors were Representative Derek Kilmer (D-WA), Gerald Connolly (D-VA), David Valadao (R-CA), and Don Bacon (R-NE). Since submission, our bill has garnered eighty-nine cosponsors. Of the eighty-nine cosponsors, sixty-seven are Democrat and twenty-two are Republican. That genuinely makes this bipartisan!

We only have one NC Cosponsor, Kathy Manning (D-6) and she is retiring at the end of the year. I have written to my member three times with no response yet.

The pre-written letters are on both the National and the State websites. I also have a list of all the addresses of our members of both the House and the Senate. This includes the addresses for their offices in Washington DC and every office they have in our state. Often it is quicker to mail a letter to the nearest in-state office than to send a letter to Washington because of all the security mail must go through there.

Until this bill passes and becomes law, we will not know exactly how Buy Back will work.








While our growth in the percentage of sessions and pageviews may not be as significant as we have discussed in past issues, that we have an increase at all means we are building on the foundation of those surges.

Hello again, Rural Craft! We are coming up on the State Convention and boy do we have a lot to talk about. As we know, we have recently completed the third Mini-Mail Survey and we are finalizing the disputes. If you do not get your dispute results from your manager, please contact your Steward. While it is management's responsibility to share the results with you, if you have had a change in your local management, the results may have been returned to someone who is no longer in your office.

Overall, the rural craft had a good Spring 2024 Mail Survey. Nationally, 70% of the routes increased, and the average increase was 45

minutes. If we take a closer look at our situation, it should come as no surprise that we had a net increase. The Spring 2024 Mini-Mail Survey was the first RRECS MMS that we had where we had a solid 12 months of good scanning data. If you

recall, after the disastrous first MMS, many of our carriers, nationwide, alerted the Union that their managers had instructed them to only worry about the six basic time keeping scans. This erroneous directive had major implications across the nation as the other eighteen scans (that collected mail volume data) were not properly utilized and resulted in a net loss for our craft. Once the shock of those results wore off, the craft started to really pay attention to all twenty-four scans, which provided us with 6 months of reliable data for the second MMS in the Fall of 2023. Once the third MMS rolled around this spring, we finally had a full 12 months of data that was used to determine our evaluations. Now that we have seen the difference that it makes with scanning, I am pleased that we are doing our part to ensure that our routes get all the credit that is due. I would caution us all against feeling too secure, as I would expect it to take an additional 2-4 mail surveys for us to truly work out all the kinks and feel like the process, and our routes, have somewhat stabilized.

As far as the scans are concerned, I have received information that some managers have attempted to redefine some of the scans. Most notably, FLATSWSS/LETTERSWSS and UNSCANPARCEL seem to be a focus of the postal service. I want to remind everyone that the 'RRECS Activity Scan (Key Stroke) Types' sheet that details all twenty-four scans was written and published by the USPS. We have been told that many managers have instructed carriers not to use the FLATSWSS/LETTERSWSS unless it can be confirmed that every box on the route gets a mail piece. As stated in part on the sheet, "If a flat/letter saturation mailing identified as walk sequence (WSS) has an address and has NOT been processed on automation equipment, use this keystroke (Hot Key 2 or 3) ONCE to record each set." You should not be required to hand count the total number of pieces to use this scan. If the set has 'WSS' on the label, it should be entered as such. If you are denied this credit, please keep detailed information for your disputes.

We have gotten many calls concerning management's assertion that to use the UNSCANPARCEL (Hot Key C) the parcel must be heavier than 2 lbs. and be larger than a shoebox. As stated in part on the sheet, "use UNSCANPARCEL when an

obvious parcel (not a letter or flat) is delivered and has no barcode or the label is missing or completely unreadable. Includes small parcels delivered to the mailbox and parcel lockers."

I do not know about you, but I don't know of any carrier who has a difficult time distinguishing between a letter, flat and a shoe box. If we think back to the old mail counts, the definitions of a Letter and a Flat leaves little room for negotiation. The Postal Service defines letter-size mail as follows: not less than 5" long, 5-1/2" high, or 0.007" thick, not more than 11-1/2" long, 6-1/8" high, or 1/4" thick. Flats must have one dimension that is greater than 6-1/8 inches high OR 11-½ inches long OR ¼ inch thick and be no more than 12 inches high x 15 inches long x ¾ inch thick. Bottomline is that the scans are very well defined, and the idea that rural carriers are misinterpreting those

definitions is outrageous. If you are denied this credit or any other you feel your route should have received, please notify your Steward and again, please keep detailed notes for your dispute.

As we come upon the Summer, I would ask that we all familiarize ourselves with Article 10, especially if you are intending to use any of your leave. Please remember that for other than exceptional circumstances, leave requests will not be accepted prior to 60 days in advance of the desired dates. Please make sure that you are submitting leave at least in duplicate, but preferably in triplicate, so that you can immediately receive one copy back at the time of submission (showing a managers' initials or a round date acknowledging acceptance), one copy when the request is approved/ disapproved, and the last copy is kept on file by management. Per Article 10.7.b, "failure to return a request for leave within three (3) days of receipt will result in the request being automatically approved, provided the rural carrier has obtained proper acknowledgement of the leave request submission." Alternate methods of submitting leave requests are the 1-800 number, and online for most offices.

I wanted to also remind everyone that if you are wanting to attend the state or national conventions, Article 24 of our National Agreement allows for Rural Carriers to be on LWOP, which for Union business would be coded as an F code for timekeeping purposes. Rural Carriers may use Annual Leave or LWOP, at their discretion "to attend National, State and Area Union Conventions provided that a request for leave has been submitted by the employee to the installation head as soon as practicable and provided that approval of such leave does not seriously adversely affect the service needs of the installation." Article 24.3 states that "in the event a leave replacement is not available on a rural route, the installation head will make every reasonable effort to secure a leave replacement." This means that they should also contact neighboring offices to check availability.

Please remember that once an Annual Leave request is approved, it must be honored and should not be rescinded unless there is a serious emergency situation, meaning it could not have been foreseen, and has caused serious operational hardship to the USPS.

I also want to make sure that I let everyone know that this year at the NC State Convention, I will be having a Steward Seminar for anyone who is currently a certified Steward or anyone who may be interested in becoming one, in fact, **all are welcome!** The seminar will be held from 3-5 pm on Sunday, June 16th in the convention center at the Great Wolf Lodge. It will be geared to Steward Operations and Labor issues. We will have a special guest — our National Director of Labor Relations, Bridget Boseak in attendance which will certainly add tremendous value to the event. I am hopeful to have a large crowd as knowledge is power! The time at the seminar is not compensable as it is completely voluntary and not a required class.

In addition to the Steward Seminar on Sunday, we will have a generous time slot for the Steward program during the convention. We are excited to try new things this year so I expect that we will all have a lot of fun during the Steward presentation. As usual, we will have lots of handouts and information to share. Hope to see you all there!

Procedure to File a Grievance

(See Example PS Form 8191 on next page)

You fill out the sections with red dots (# 1-4, except 3b & 3c). Management fills out the sections with the blue dots (#3b & 3c) when **you** actually file (discuss the issue) the grievance with them. (THIS DISCUSSION MUST BE WITHIN 14 DAYS FROM THE DATE IN 3a).

Once you have filed, let management make themselves a copy and you must get the original to the steward or representative immediately. The steward or representative **only has 10 days** from the date in 3b to setup a meeting with management.

Include a signed and dated statement telling your side of the issue. This statement is for the steward only. Management will not see your statement.

Never hesitate to call your steward or representative with questions if you need assistance. Never put your entire statement in #4 on the grievance form (PS Form 8191). <u>Just state the issue in the form of a single question</u>. Then, provide the steward with a statement explaining your side of the issue.

NOTE: Just filling out a grievance (PS Form 8191) and sending it to the steward or representative is NOT filing a grievance. You must discuss the issue with management at the time you are filing the grievance and follow the proper procedure.

Management must fill out sections 3b & 3c.

- Unions negotiate raises for every one. Members vote on it, and if they feel it's an unfair, they can vote it down.
- 4. If you are unfairly disciplined, unions provide due process to protect against unscrupulous supervisors.
- 5. If you don't like something at work you can work together with your union to change it.

Non-Union

- Management can change wages, benefits and working conditions unilaterally.
- No one knows how much anyone else earns. Disparate treatment/favoritism exists.
- If you want a raise you must plead your case to a supervisor or manager.
- If you are unfairly disciplined, you are on your own (at-will employee). You're subject solely to policy.
- If you don't like something at work, you are at the mercy of management.
