# CHANGES ARE COMIN'

Hello everyone. I hope this third mini survey went a little smoother. By the time you read this article, you will have already heard about the upcoming changes. The South Atlantic Conference was filled with information about these upcoming events.

March 5 will start contract negotiations.

April will start route adjustments which will be approximately 887 routes in NC. Routes 57.36 (48K) and above will adjust first. Remember you have the right to make suggestions on the adjustment. Suggestions should be in writing and signed by both parties. Remember routes will (more than likely) and can adjust to a 43K. EXCEPTION: if you are performing all duties under evaluation, your route will not be immediately adjusted. (See your Steward for more information)

April all State Presidents will be traveling to Washington D.C. for the annual Legislative Seminar. Buy back bill (HR 5995 Federal Retirement Act) needs your help. Please write, email, or call your representative to get this bill moving. Go to the NRLCA website (Legislative Updates) or the NCRLCA website (PAC Legislative) to see a form letter and personalize it. You will also find the letters for HR 3721, USPS Shipping Equity Act and HR 82,

Social Security Fairness Act. WE NEED YOUR HELP!

Summer 2024 will bring in more SD&C's (currently there are seven in the Atlantic Area).

- \* Same day/next day deliveries from SD&C's.
- \* New Vehicles should start deploying.
- Rural Route Optimization will begin. Using the updated software and technology the Postal Service can now determine the most sustainable, cost-effective, and timely routes in each office.

Now to move on, if you are waiting for a pay adjustment, I am sorry to inform you that the timeline has increased. It can take anywhere from four to eight pay periods for Regular carriers and eight to twelve pay periods for RCAs.

We would like to congratulate our National Auxiliary (especially our NC Auxiliary) on their 100th Anniversary. THANKS FOR ALL YOU DO

It is now time for District Meetings. Please ensure you secure a Board Member and a Steward for your meeting. Do not send out dates and times without confirmation that the Board Member and Steward will be in attendance.

The State Convention will be at Great Wolf Lodge, Concord, NC, June 17-19. More information to be announced. DO NOT FORGET that to be a paid delegate you must be an elected delegate from your district and send in the delegate registration form by the deadline.

# It's The Law (I think?)

I heard of an accident recently that involved a carrier turning left and being hit by a passing motorist. It happened in a No Passing Zone which made the driver making the pass at fault. But had it been in a passing zone, it would have been the fault of the carrier.

Sometimes we act in the way we think the law is when in fact the law states something a bit different. With the time we spend moving in traffic we must always be on guard. After all, we are professional drivers.

As for the passing incident I alluded to earlier, it is covered under NC General Statute 20-150. Here is an excerpt from that statute:

(e) The driver of a vehicle shall not overtake and pass another on any portion of the highway which is marked by signs, markers or markings placed by the Department of Transportation stating or clearly indicating that passing should not be attempted. The prohibition in this section shall not apply when the overtaking and passing is done in accordance with ALL of the following:

- (1) The slower moving vehicle to be passed is a bicycle or a moped.
- (2) The slower moving vehicle is proceeding in the same direction as the faster moving vehicle.
- (3) The driver of the faster moving vehicle either
  - (I) provides a minimum of four feet between the faster moving vehicle and the slower moving vehicle or
  - (ii) completely enters the left lane of the highway.
- (4) The operator of the slower moving vehicle is not
  - (I) making a left turn or
  - (ii) signaling in accordance with G.S. 20-154 that he or she intends to make a left turn.
- (5) The driver of the faster moving vehicle complies with all other applicable requirements set forth in this section.

I know we all have people zoom by us every day, passing zone or not, but that appears to be against the above statute. Does that mean we should spin tires from every mailbox in a "No Passing" zone? Of course not. We are professional drivers and regardless of the activity we have going on in our delivery vehicles we have to make sure that when we are driving that is all we are doing. We should not be fingering the mail, sorting parcels, making scanner entries, or anything else while we drive.

This is highlighting just one of the many laws that we must adhere to every day. North Carolina G.S. Chapter 20 (Motor Vehicles) contains many of the relevant statutes related to driving, license privileges, the DMV, etc. You can read and search the General Statutes yourself at <a href="ncleg.gov">ncleg.gov</a> and click on the Bills & Laws tab. As the saying goes, "Ignorance of the law excuses not."

I cannot stress enough the importance of safe and defensive driving. In January of this year we lost David Troutman, a rural carrier in Kansas in an on-the-job vehicle accident. He had served his state Association as their past president and I, although never having a personal interaction with him, had seen him on the convention floor at National Convention.

I do not know the details of David's accident. I am just pointing out that accidents can happen to any one of us. Accidents are not exclusive to new and inexperienced carriers. Complacency and inattention can cause any one of us to be involved in a crash. You owe it to your family and friends to do everything YOU can to make it home safely.

# How Long Will It Take?


I have been taking phone calls about retirement for the past two years and more often than not, carriers don't realize how long the process will be from the last day on the rolls until your retirement is finalized. This chart shows how long OPM takes to process claims once they receive your retirement application.

Example - Someone decides their last day with the post office will be 12/28/23 so they are retired on

12/29/23. The next pay dates are 1/5/24 and 1/19/24. Depending on how far ahead retirement paperwork was mailed in to HRSSC in the process, it must be sent to Eagan for readiness for last pay to be processed.

Once your final postal pay is completed, generally the retirement paperwork then goes on a register to Office of Personnel Management (OPM) around the pay-date.

So no one's paperwork can ever leave USPS until after they get paid their final pay (including the lump sum of annual leave). This is one reason it may feel longer for the carriers waiting to bid on the vacant route. Even if the newly retired carrier is no longer on the route, it is not officially vacant until the carriers actual retirement date.

In this example, February is the first month that anything starts to come from OPM, do not start counting the months until February. After OPM receives your packet, 2-5 months is an average time it takes them to complete your final retirement.

Things that make that take longer is temporary time, RCA or military, that someone is eligible to do a deposit for and has never done it, anyone that was on OWCP at the time they were retiring and of course divorce stuff. Then things can drag out the process longer.

January are more popular times carriers want out, so many more cases hit OPM than other months during the year. That has an impact if you notice the higher average processing time on the chart below.

If someone sends in their paperwork to HRSSC and then something is wrong and it comes back to them, it will significantly delay the process. Something as simple as not making a choice for survivor benefits, missing a signature or any other little issues.

Every case can be different. Please be prepared for longer rather than hoping for a best case scenario.

# Spring Is Allergy Season

Spring is here and that means blooming flowers, new foliage, insect bites, and Bee Stings. It is a beautiful time of year unless you are an allergy sufferer. Be prepared by visiting your doctor, utilizing the free telehealth services by visiting Teladoc.com/Aetna or call **1-855-835-2362**, or visit a CVS minute clinic, all these are offered by the Rural Carrier Benefit Plan.

Seasonal allergy signs and symptoms can flare up when there's a lot of pollen in the air. These steps can help you reduce your exposure:

- Check your local TV or radio station, your local newspaper, or the internet for pollen forecasts and current pollen levels.
- If high pollen counts are forecasted, start taking allergy medications before your symptoms start.
- Close doors and windows at night if possible or any other time when pollen counts are high.
- Avoid outdoor activity in the early morning when pollen counts are highest.

Several types of nonprescription medications can help ease allergy symptoms. They include:

- Oral antihistamines
- Corticosteroid nasal sprays
- Cromolyn sodium nasal spray
- Oral decongestants

Although most bug bites are harmless, some can spread dangerous diseases like Zika virus, dengue, Lyme disease, and malaria. Particularly if you're visiting areas with known insect-borne diseases, it's

important to take steps to reduce your risk. If you are allergic to bees always keep your EpiPen with you!!

To help prevent bug bites, use the following tips:

- Use insect repellent.
- Wear appropriate clothing.
- Check mailboxes for bugs and bees.
- Watch your steps, some bees and insects build nests in the ground.

To treat bug bites and stings at home dermatologists recommend the following tips:

- 1. For painful bites or bee stings, take an over-thecounter painkiller, such as acetaminophen or ibuprofen. Always follow the directions on the label and use the correct dose.
- 2. For bites that itch, apply an ice pack or an overthe-counter anti-itch cream, such as hydrocortisone. Another option is to take an over -the-counter oral antihistamine.

3. To reduce swelling, apply an ice pack to the bite.

Pay attention to outbreaks.
Check the CDC Travel
Health Notices website and
heed travel warnings and
recommendations.

If you experience any serious symptoms after a bug bite, such as a rash, fever, or body aches, see your doctor or a board-certified dermatologist immediately. Make sure you tell the doctor about your recent bite so that they can examine you for a transmitted disease.

# When to seek emergency care

Call 911 or your local medical emergency number if you or someone is having a serious reaction that suggests anaphylaxis, even if it's just one or two signs or symptoms:

- Trouble breathing
- Swelling of the lips, face, eyelids or throat
- Dizziness, fainting or unconsciousness.
- A weak and rapid pulse
- Hives

# Cost-of-Living Adjustment (COLA) Effective March 9, 2024

Pursuant to the release of the January 2024 Consumer Price Index - Urban Wage and Clerical Workers (CPI-W), and in accordance with Article 9.1.E, the sixth and final COLA adjustment of the 2021-2024 National Agreement will result in a \$353.00 increase for eligible rural carriers. This COLA adjustment will be effective March 9, 2024 (PP 2024-07). All COLA adjustments are based on a 40-hour evaluation with proportional application to those route evaluations over 40 hours. The increase should appear in paychecks dated **March 29, 2024.** 

In accordance with Article 9.1.E.3, full COLA adjustments will apply to Table One and the new Step 15 of Table Two. COLA adjustments to Steps 1 through 14 of Table Two will be adjusted proportionally to each step's percentage of Step 15. This will serve to bring Table Two schedule (Step 15) employees to the same pay level as Table One (Step 12) employees, thereby eliminating the pay differential between Table Two and Table One employees at the top step and for the rest of their careers.

NOTE: All leave replacement employees will receive an additional 1% salary adjustment annually in lieu of COLA adjustments.

Updated pay schedules will be posted on our website when available and will also be included in a future edition of *The National Rural Letter Carrier* magazine.



• Nausea, vomiting or diarrhea.

Take these actions immediately while waiting for medical help:

- Ask whether the injured person is carrying an epinephrine autoinjector (EpiPen, Auvi-Q, others).
- Ask whether you should help inject the medication. This is usually done by pressing the autoinjector against the thigh and holding it in place for several seconds.
- Loosen tight clothing and cover the person with a blanket.
- **Don't** offer anything to drink.
- If needed, position the person to prevent choking on vomit.

new member to the firm, Debra Bogaslaw, On March 5<sup>th</sup> contract negotiations will begin. Mr. Favreau spoke on the Labor Movement (Writers Strike, UPS, United Auto Workers) and gains in Unions. Wage increases, RCA hire, and retention, inability to hire, the Step 4 Grievance on Postal Service's Failure to Pay Rural Carriers Correctly Back payments/non-payments, Amazon parcels, Long-standing "unusual conditions" of cutting the over-burned routes. Article 9

Paul Swartz, NRLCA Director of Governmental Affairs gave us some important dates to remember. April 1st, 2024, annuitants who did not sign up for Part B at the age of 65 can enroll penalty-free. This is a six-month period. Individuals who qualify for the SEP will receive a separate notification before April 1, 2024, as required by the PSRA. Annuitant and their family members who are entitled to Medicare Part A must enroll in Medicare Part B to be eligible to continue PSHB coverage. Current annuitants will not be required to enroll in Medicare Part B if they choose to stay out. Some limited exceptions will apply. Medicare integration will go into effect in January 2025. Here are some links where you can get more information: Log into opm.gov click on the Insurance tab then Postal Service Health Benefits Plan or you can log on to LiteBlue. Retirees can stay informed by logging in Online at <a href="https://www.keepingposted.org">https://www.keepingposted.org</a> or text 39369. Click the tabs and they will send you all kinds of information such as benefits, retirement, etc.

Mr. Swartz also spoke about what's going on, on the Hill. HR 5995. "Federal Retirement Fairness Act (FRFA) better known as the BUY BACK legislation. This would provide rural letter carriers who served as relief employees after December 31, 1988 the opportunity to buy back credit for service. The FRFA impacts not only rural letter carriers but other federal employees as well, who began their employment as non-career workers and did not have the ability to make retirement contributions.

HR 3721, "USPS Shipping Equity Act" would provide the United States Postal Service the authority to mail alcoholic beverages. Currently has 17 cosponsors. This is estimated to be 180 million dollars in new revenue. UPS & Fed EX deliver it, why can't we? This does not supersede any Law where a Dry County is, that county will not get this service.

HR 82, "Social Security Fairness Act of 2023" eliminates both the WEP and GPO. It went to the Ways and Means Committee, we're waiting on a

hearing, but Social Security is looking at the financial impact this would have.

We need you to call/write your Senators and congressional representatives. You can find form letters on the National site that you can edit to make personal. Contact your PAC or Legislative person if you need help with this.

Ted Borgstadt of Trestle Tree talked about 'health coaches'. He told stories from health coaches who can help with your needs on diabetes, weight management, and more.

Calvin Stevens of NARFE, NARFE is celebrating 102 years this year, For more information checkout NARFE.org.

President Don Maston talked about the upcoming contract negotiations. The route adjustments will start with routes that are the most overburdened. The Postmaster General invited the worker's family to go into S&DC to tour them. Updated Academy Training should be launched soon. RRECS- if you are not mapping routes- YOU MUST START, make sure the Safety Service Talks are entered in REMMS. Still finding the Radar Reports are still not 100%.

Carolina is the biggest District in the Atlantic Area; With the biggest growth. We delivered 3.1 million more parcels this year. He spoke on Delivering for America, the new Service Transfer Centers (STC), a lot more will be insourced, RPDC Delivery center and Transfer hubs Atlantic Area has 7 of the units, 31 active S&DC. There are 662 Rural Routes in them, and 300 spoke offices that still have retail but the carriers have moved out. A bit closer to home, the Asheville S&DC projected date is June 2024.

Derek Strissel, Central Area Manager Operation Integration, spoke on RRECs Enhancement, the training in October 2023 that managers were to do, and many did not. He gave the date for the next Mail survey as February 24, 2024, to March 8, 2024, #3, March 15 All Mini Mail Survey entries must be reviewed and finalized, April 6 is the effective date of RRECS Evaluation 3. He also spoke on the overburdened routes. PO 603, (every carrier has one at the case if not, your manager can order a copy) Please give your input in writing.

We ended SAC with a Q&A session and the swearing-in of the New SAC Board.

Be a part- North Carolina has 887 overburdened routes. I cannot stress those to carriers of overburdened routes enough. \* Per Article 9 & Article 30.1.J. Carrier's Rights in Route Adjustments- The regular rural carrier assigned to the route shall be notified in advance of any route adjustments and afforded the opportunity to submit comments in writing. The comments will be considered as a factor when such adjustments are under consideration and before any decision is made. Substantial route adjustment must be approved at a level higher than the installation and, if requested in writing, will be reviewed at the district level, except for adjustments to avoid actual work hours in excess of 2,080 during the guarantee period. Please submit comments in writing before the adjustments take place and before any decision is made.

BE A PART I cannot stress that enough. If you don't understand or know your rights. Contact your Steward to get the information you need to make the best decision. Go to your Spring meetings and ask the questions.

# **National Convention**

### **National Delegate Election by Secret Ballot**

This year the National Convention will be held in Reno, Nevada from August 27-30, 2024.

A secret ballot election for the delegates of the North Carolina RLCA to the 2024 NRLCA National Convention will be conducted by mail.

# The deadline for delegate nominations this year is April 29, 2024.

Anything received after that date will be returned to the sender as post office box closed.

Ballots will be mailed to members between May 17 and May 23, 2024.

Any eligible member who does not receive a ballot or whom spoils a ballot may request a new ballot by contacting the Election Committee Chairperson, Debra Bennett at 910-436-6487. If you request and return another ballot, only the replacement ballot will be counted.

Counting of the National Delegate ballots will take place on Saturday June 15, 2024 beginning at 10:00 AM at Great Wolf Lodge in Concord, NC.

Any candidate or designee may observe the ballot tabulation.

Included here are the rules for delegate nomination from the *NRLCA constitution*, Article VI.

### **Section 2. Delegates**

### A. Eligibility

- 2. Only Bargaining Unit Members and Retired Members in good standing may be nominated, elected or seated as delegates. Such "good standing" status shall be the sole prerequisite for determining eligibility or entitlement to service as a delegate or to any payment or benefit, except that a state may establish reasonable rules to ensure attendance at the Convention.
- 3. A member who accepts or acts at any time in any capacity normally performed by a manager from the end of one Convention to the end of the next

Convention shall be ineligible to be nominated or serve as delegate.

### **B.** Nomination

- 1. Within each state association, nominations for National Delegate shall be submitted by U.S. Mail to a pre-arranged post office box on a nominating ballot or copy. The nominating ballot shall be signed and show the name and address of the member making the nomination, and may include self-nomination. The nominating ballot and instructions shall be posted on the NRLCA website and in all published issues of *The National Rural Letter Carrier* from February May.
- 2. Nominations must be received in the prearranged post office box at least 50 days prior to the opening of the state convention. (This year that day is April 29, 2024.)

# **State Convention**

The State Convention will be held at Great Wolf Lodge at 10175 Weddington Rd, Concord, NC 28027 on June 17 thru June 19, 2024 with the business session starting on Monday June 17. Complete address and reservation information for the State Convention can be found on the back page of this issue.

Elections for the positions of President, Vice-President (one year terms), Secretary/Treasurer (two year term) and Executive Committeeman (three year term) will be conducted on Wednesday June 19, 2024.

Included below are the rules for State delegates from the *North Carolina RLCA constitution*, Article VI.

### **Section 3. State Delegates.**

- A. All districts shall be entitled to one delegate vote for each six paid-up members or a fraction thereof.
- B. No delegate shall represent more than one district.
- C. No district shall be represented in the State (Continued on page 16)

# **Candidate Announcements for State Office**

The state officer positions up for election are President (one year term), Vice-President (one year term) and Executive Committeeman (three year term).

To have your candidacy announcements printed in our newsletter they **must be received by April 15, 2024.** Any late submissions will not be printed.

All articles are limited to a maximum of **150 words** and will be cut off at that point. They will be printed verbatim with no editing by the editor. In other words, you are responsible for all the content of your submission.

Announcements will appear in the NCRC May/June issue.

Carriers currently serving in a management position are <u>not eligible</u> to run for a position in the Union.

D. The total delegates from a district (if not in full attendance) may be voted by the one or more delegates in attendance.

# State Convention Preregistration

Appearing below is Article VI, Section 4 from the Constitution of the North Carolina Rural Letter Carriers' Association. This language was adopted at the 2019 State Convention in Raleigh.

This is the procedure put in place for our members to be compensated (paid) for attending the state convention as delegates.

Members must also be elected to serve as delegates at the local meeting; as per Article IV.

This complies with labor laws which require that delegates must be elected by a direct vote of the membership.

Mail the completely filled out and signed preregistration form to me. (Form on the next page) Please print clearly as an illegible registration may cause it to be to deemed unacceptable.

You must preregister to be eligible to receive payment as a delegate.

Forms may be copied and will also be available on the website www.NCRLCA.org.

Forms must be received by May 16, 2024. Please send in as early as possible.

# **ARTICLE VI, Section 4 State Delegate Compensation**

- A. State delegates shall be compensated up to \$100.00 per each completed business session day of attendance at the State Convention for expenses.
- B. The state shall set aside a total amount equal to the rate of .00017% of a 40 hour, Step C, Table 1 regular rural carrier's yearly pay for each member on the rolls on June 30, to be used to pay state delegates. (proviso first deposit will be July 2019)
- C. These funds shall be held in an interest-bearing account.
- D. The maximum amount to be paid out per year will be \$60,000.
- E. Any state delegate to the State Convention who is being compensated for the State Convention by (Continued on page 17)

- F. All state delegate checks will be mailed by July 31 or within 30 days of the close of the State Convention if delayed
- G. All state delegates must preregister by submitting the registration form that will be printed in the convention issue of the state newspaper and on the North Carolina website.
- H. Preregistration forms must be received by the Secretary Treasurer at least 30 days prior to the opening of the State Convention. (That day is May 16th this year.)

# GUIDELINES FOR SELECTION OF OUTSTANDING MEMBER OF THE YEAR

### I. Method of Selection

- 1. Nomination of candidates for the award shall be made prior to the State Convention. Nominations may be made directly from the members inviting such nominations. Also, local, county or district units may select candidates for the award.
- 2. In either event, the name of the candidate should be submitted, with a brief resume of accomplishments, to a Selection Committee to be named by the State Board, or by any other means, which may be the prevailing policy in the State Association.

### II. Eligibility for Award

- 1. Any MEMBER of the Association may be nominated as a candidate for the Outstanding Member of the Year Award.
- 2. State Association Officers should not be arbitrarily selected for the award nor should they be eliminated from consideration. Officers have been chosen to lead and serve, but it is frequently demonstrated that their services go far beyond the routine duties of the office and, thus may be worthy of selection.

### III. Criteria for Selection

- 1. The primary consideration of the Selection Committee shall be:
- (a) The service rendered by the candidate to the Rural Letter Carriers' Association;
- (b) Attendance and participation in local, state and national meetings;
- (c) Willingness to accept responsibilities and dedication in performing those duties;
- (d) Fraternal Attitude to others of the Rural Carrier Craft.
- 2. The Selection Committee should also consider, as a secondary matter, other service which the candidate may have rendered, such as civic and community activities, which reflect favorably upon the Rural Letter Carrier Craft and the Postal Service.
- 3. Consideration shall be given for services rendered in the immediately preceding twelve-month period, but not completely limited to this period of time. New carriers

should be encouraged to seek to achieve this award.

### IV. Presentation of Award

When each State Association has made its selection, the name of the candidate shall be reported to the

National Office by the State Secretary on the regular Annual Report. An appropriate award will be presented by the National Rural Letter Carriers' Association at its National Convention.

### V. Other

These guidelines are not intended to be binding and a State may use any other selection procedure that is suitable for each State.

The announcement of the recipient of the award will be made at the banquet at the State Convention. The State Secretary shall report the name to the National Office and the award will be presented at the National Convention with State presentation at the Fall Booster.

This year the State Board has appointed the immediate past three recipients of the award to serve as the Selection Committee.



# It's Springtime In Washington

Legislative Representative

Okay, what does that title mean? In May, NRLCA State Presidents and Vice-Presidents will be gathering in Washington DC to speak to our members of Congress about issues that are important to Rural Carriers. When I say Rural Carriers, I am talking about every job covered by the NRLCA.

To support our Teams going to Washington, we need to write letters and make phone calls to Washington. When President Solomon and Vice-President Althoff sit down with a member of Congress or a member of their staff to talk about a specific bill, the Member or their Staff Member can say, "Oh yes, we have received a number of letters from Rural Carriers in our District about that bill," it really helps to make our point as to whether we want the bill passed or defeated. It really does have influence.

Remember, we have sample letters on most bills available on both the National and State websites. Please take advantage of these sample letters and send Washington a letter.

HR 82/S 597 – Social Security Fairness Act

This bill repeals provisions that reduce Social Security benefits for individuals who receive other benefits, such as a pension from a state or local government.

Since we last spoke this bill has been referred to the House Ways and Means Committee. This is the normal path a bill takes. We have not picked up any more cosponsors from NC. We have the same six that I told you about last time. There are overall 308 cosponsor, 203 Democrats, 105 Republicans.

In the Senate, S597 has fifty cosponsors. Neither Senator Tillis nor Budd signed onto this bill.

HR 5995 – Federal Retirement Fairness Act

This is the bill that we call "Buy Back." Not much is happening with this bill. Currently there are seventy four cosponsors, none from our state. My previous member of Congress was a dependable sponsor of this bill. My new member of Congress, even though I

have written to him several times, has still not signed onto this especially important bill. Have you, dear reader, written or called your member on this bill? Let's lay it out plainly. This bill would affect the retirement for every RCA that plans to work to retirement. It would affect every Regular Carrier still working when it passes as well as PTFs. For those of us who are fortunate to have already retired, we should be supporting this bill for the benefit of our brothers and sisters that are still working. It is simply the right thing to do.

The pre-written letters are on both the National and the State websites. I also have a list of all the addresses of our members of both the House and the Senate. This includes the addresses for their offices in Washington DC and every office they have in our state. Often it is quicker to mail a letter to the nearest in-state office than to send a letter to Washington because of all the security mail must go through there.

Until and if this bill passes and becomes law, we will not know exactly how Buy Back will work. The actual text of the bill states: "The Director of the OPM shall notify agency Chief Human Capital Officers or other appropriate agency officials for purposes of providing notice to employees and Members who are eligible to make a deposit for service."

Paul Swartz updated us at SAC on the following legislation in Congress.

**H.R. 5995** The Federal Postal Coalition bill has 56 co-sponsors and would cost \$10 billion over 10 years without including postal employees and set at 1.3%.

**H.R. 3721** The United Stated Postal Service Equity Act has 17 co-sponsors and is worth \$180 billion per year in income for the Postal Service.

**H.R. 82** The Social Security Fairness Act has 304 co-sponsors and would repeal WEP (windfall elimination) and GPO (government pension offset).

You can download the letters from the NRLCA website to mail to your representative. Celeste and I will bring some of these to the district meetings.

If you signed up to become a sustaining donor during the National Convention, there were some issues causing some withdrawals to be overlooked. This should be corrected by the end of the month.

# Signing up for PAC Withholding from your Paycheck

Active carriers may elect to use one of their three payroll allotments to donate every two weeks. You must sign up for withholding exclusively through PostalEASE.

Have readily available **your 8-digit Employee ID Number** (on your paycheck stub) and your **4-digit USPS PIN or password.** If you don't have your USPS PIN you will need to call PostalEASE at: 877-477-3273. Press #1 for PostalEASE. When prompted, enter your employee identification number. When prompted for your pin, pause, and then press #2. Your PIN will be mailed to your address on the next business day.

## **Steps for signing up Online:**

- 1. Add your Employee I.D. number to the end of the 9-digit NRLCA-PAC Account (163055555) to create your PostalEASE account number.
- 2. Now you are ready to log into: liteblue.usps.gov.
- 3. Enter your employee I.D. number and password, then click "log on."
- 4. Click on "PostalEASE."
- 5. Click on "I Agree."
- 6. Enter your Employee I.D. and password again and log in.
- 7. Click on "Allotments/Payroll NTB."
- 8. Click on "Continue."
- 9. Click on "Allotments."
- 10. Enter the following Financial Institution routing number: 051400549
- 11. Enter your NRLCA account number, followed by your Employee I.D.#:163055555\_\_\_\_\_, (No hyphens, No breaks, 17 digits total).
- 12. Enter account type as "Checking."
- 13. Enter the amount you want to be taken out **every two [2] weeks** not the amount you want to give yearly.
- 14. Click on "Validate."
- 15. Click on "Submit."
- 16. Click on "print page" to see and print your confirmation number for your records.

## **Steps for signing up by Phone:**

- 1. Dial 1-877-477-3273 (1-877-4PS-EASE).
- 2. Press "1" for PostalEASE.
- 3. When prompted, enter your Employee ID Number.
- 4. When prompted, enter your USPS Pin Number.
- 5. When prompted, choose option #2 to select Payroll Allotments.
- 6. When prompted, choose option #1 to select type of Allotment. When prompted, press "2" to continue.
- 1. When prompted, press "3" to continue to 'ADD' the allotment.
- 2. When prompted, add routing number: 051400549.
- 3. When prompted, add the NRLCA-PAC account # followed by your Employee ID Number. It should look like: **163055555\_\_\_\_\_**. No hyphens, no spaces, 17 digits total. If correct, Press "1."
- 4. When prompted, press "1" for checking.
- 5. When prompted for the dollar amount of the allotment, enter the amount of your choice to be deducted bi-weekly (per pay period) using the \$ 00 format. Press "1" if correct.
- 6. When prompted, press "1" to process.
- 7. Record the confirmation number given for your records and note the date the first allotment will take place. Press "1" to repeat, or press "9" to hang up.



# 11 Things Affecting Your Car Insurance Rates

- 1. Age and Gender Statistics show that teenager and young adult males receive more citations and get into more accidents than their female counterparts. The opposite is generally true for senior drivers. Data shows that older females actually experience more minor accidents as they age.
- 2. **Marital Status** Married couples are generally more responsible behind the wheel as opposed to singles, as they tend to be more family oriented. Some newly-married couples may see their premiums drop by as much as 50% since car insurance companies will see them as less of a risk.
- 3. Where You Live You may have heard that most traffic accidents occur close to the home, which makes sense since the area in which you live is typically where you're driving the most. If you live in a highly-populated area, there are more risks since there are more cars on the road, leaving you more vulnerable to experience an accident, or be a victim of theft. If you reside in an upscale neighborhood, and have an accident that results in property damage, your costs will also generally be higher.
- **4. Credit Score & History** Just like everything else, credit history affects your rates. The worse-off your credit report, the higher your rates will be.
- 5. Your Job and Your Commute Those who hold jobs that require a lot of driving or traveling, like delivery drivers or sales representatives, are at a higher risk of getting into an accident since they are on the road more. If you have an office job or something else that doesn't require any additional driving besides your normal commute the person who only has to drive 10 minutes to get to work will be at lower risk than the person who has to drive 45 minutes, an hour, and so on. But it

- also includes how often you drive in general. For instance, if you live in North Carolina, but frequently go see your family or old friends up in Virginia on the weekends, you, again, are at more of a risk of getting into an accident.
- 6. Your Vehicle's Safety Rating Cars that have a lot of safety features, such as airbags, lane-departure warning, back-up camera, blind-spot alerts, adaptive cruise control, etc. will both help prevent an accident and likely leave you with less injuries if an accident did occur. Car insurance companies also generally see SUVs,

trucks, and minivans as safer vehicles than sedans, coupes, and compact cars.

- 7. **Engine Size** The larger and more powerful your engine, the higher your rate will be, since sports cars are made to be driven fast and aggressively, which means a higher risk of a collision.
- 8. Your Vehicle's Age Collision coverage rates for newer cars are higher than for older ones, simply because they're generally worth more. Collision insurance is usually required for new cars also since a majority of

new cars are financed and the lending companies will require that you get full coverage during the term of your loan. Older vehicles that are involved in a wreck, most times will incur damages that will cost more than the cost of the vehicle is worth all together, and you will likely just have to get a newer vehicle to replace it.

- 9. Your Vehicle's Rate of Theft Every year, a list of top 10 most popular stolen cars is released. So, if the vehicle you drive is on this list, there's a good chance your rates will increase.
- 10. Your Personal Driving History Well, this one should be obvious. The more accidents and moving violations on your record, the higher your rates will be. And, if you have a clean driving record, you should be getting the cheapest rates, since you are at a much lower risk. Accidents and violations, however, don't stay on your record forever, so the longer you go without an accident or speeding ticket, the lower your rates will be over time.
- 11. Where You Purchase Your Insurance Rural Carrier's have a greater chance of lowering their current auto insurance rate by shopping with National General Insurance. 

# North Carolina District Representative

Spring has sprung and as we move through the first quarter of 2024, I hope this new year has found each of you well. We have just completed the third Mini-Mail Survey and we are about to embark on disputes once again. Make sure that you refer to the documentation requirements posted on the National website (nrlca.org) before your disputes are sent off. Please remember, if no documentation is provided with your disputes, we will not be able to do much of anything with them. Documentation is essential to a successful dispute!!

The weather is getting warmer, and people are spending more time outside which causes me to think about several things. With Spring, we are back to focusing on our need to stay on top of our health, ensure that you are properly hydrated, stay away

from direct-sun exposure as much as possible and always wear your sunscreen. Also, warmer weather means that we will be seeing more kids and pets outside playing so it would be wise to refocus our attention on our safety, and the safety of our customers, both the two- and four-legged kind. Pay attention to plants and vines growing around the mailboxes you serve – that is home to a lot of critters that sting and bite.

For this month's article, I wanted to address something that is starting to concern me. I have noticed that over the last several months, we have seen a considerable increase in carriers receiving discipline for failure to follow instructions. We have carriers who are saying no to direct orders, carriers walking off the job when given a direct order they object to, carriers yelling and cursing out management, amongst other things. I must caution our craft against behaving this way. The Postal

Service is a very militaristic environment where expectations are that employees obey the directives of management. There are two occasions when we can object to a direct order and those two occasions are when the directive is illegal, or when the directive is unsafe. If the directive is legal and will not jeopardize our safety, we must comply with our orders and if we believe them to be outside our contract, then filing a grievance is the appropriate next step. Walking off the job or arguing with management is not the proper way to handle your objections. Please comply and file a grievance!

There is no denying that our craft is exhausted. It has been several years since I remember a 'slow season.' We have lost so many people and management's failure to staff our craft has caused the leave replacements to work outrageous hours and regulars to feel compelled to chip in and try to help. I understand that it is difficult to blindly accept an order that we do not want to do as fatigue and frustration are sometimes difficult to see past, but the reality of our jobs is that management is the party that makes

decisions, and we are the party that executes those decisions. When we fail to comply with a safe and lawful order, we are opening the door to discipline, up to and including removal. I implore each of you to consider the potential consequences of your decisions, and to act accordingly.

Please understand that you will eventually have to answer for those choices, and sometimes a momentary lapse in judgement can turn your life upside down. I have seen firsthand how that split-second decision made in anger can cause tremendous hardship in a carrier's life. Please do not do that to yourself and your family.

Lastly, please remember that Edit Books and mapping are here to stay! Please keep your Edit Books up to date and make sure that you are reviewing your LTM/DPM on a regular basis. If you are having problems getting your Edit book for updates or you have not been permitted to review and update LTM/DPM, please contact your Steward! Happy March everyone!

# Procedure to File a Grievance

(See Example PS Form 8191 on next page)

You fill out the sections with red dots (# 1 - 4, except 3b & 3c). Management fills out the sections with the blue dots (#3b & 3c) when <u>vou</u> actually file (discuss the issue) the grievance with them. (THIS DISCUSSION MUST BE WITHIN 14 DAYS FROM THE DATE IN 3a).

Once you have filed, let management make themselves a copy and you must get the original to the steward or representative immediately. The steward or representative **only has 10 days** from the date in 3b to setup a meeting with management.

Include a signed and dated statement telling your side of the issue. This statement is for the steward only. Management will not see your statement.

Never hesitate to call your steward or representative with questions if you need assistance. Never put your entire statement in #4 on the grievance form (PS Form 8191). <u>Just state the issue in the form of a single question</u>. Then, provide the steward with a statement explaining your side of the issue.

**NOTE:** Just filling out a grievance (PS Form 8191) and sending it to the steward or representative is NOT filing a grievance. You must discuss the issue with management at the time you are filing the grievance and follow the proper procedure.

Management must fill out sections 3b & 3c.
