Hello everyone. It has been very busy for the State Board as we gear up for the Convention. By the time this hits your mail box the State Convention will be over.

Ratification:

As we were in sessions, the ratification results were announced by our National Officer Jeanette Dwyer.

Here are the results for North Carolina ballots for Ratification 4,336 Ballots were sent out, 613 Ballots were received.

Nationwide Ballots in favor of ratification 9,730, opposed 4,880, Void ballots 40, total 14,650. For a more detailed breakdown, log on to the national website.

I want to **thank each of you** for attending the inperson ratification meeting with our Labor Relations Director, John Adams. The turnout was at an all-time low, but this allowed us to ask questions and gain a more in-depth understanding of the changes in the contract. At the Zoom meeting I was not able to gauge how many were logged in during the presentation. Just remember, there is no "Perfect Contract".

On The Horizon

Folks, we have a true fight on our hands with a new Postmaster General about to be placed and four seats for him to set. If this is not your wake-up call, I don't know what is. **Write your representative.** I strongly encourage you to get involved. This union is built on active, informed members. The ratification meeting, Spring Meetings, State Convention, Fall Booster and National Convention are gatherings to inform and get our message out and fight for the rights of each of our brothers and sisters.

We cannot do it alone. We need you to become more active in your union and in the fight against the Reform Committee and their harmful cuts. This will not only impact your livelihood, it impacts the retiree's and any future rural letter carriers as well.

Anticipation of National Convention delegate and contract ratification results filled the room Monday morning. But that was after a well attended retirement seminar Sunday afternoon by Joni Montroy of Key Retirement Solutions.

At exactly 11:00, NRLCA National Officer and North Carolina's own Jeanette Dwyer announced the ratification of the membership vote on the proposed contract. There was disappointing news on the lack of participation by our membership. Here are the North Carolina numbers:

Against - 223

Spoiled – 1

Every meeting, the conversation about how to increase participation happens. This years second timers of 40 and third timers (Trenders) was also 40, was a great increase over previous years participation.

Dr. LaTacia Ruff came and discussed the Employee Assistance Program (EAP). Everything is confidential and the first consultation is on the clock. 1-800-EAP-4YOU.

After lunch, Jeanette spoke on the process of contract negotiations and the back and forth of proposals put forward by each side. Postal negotiators put out to eliminate the high option, NRLCA says no. NRLCA proposes eliminating table 2 pay, postal negotiators say no. The back and forth happens until both sides can agree on something.

The Heat Is On! Stay Hydrated! Stay Protected!

Hello, fellow rural carriers, the heat is kicking in! It's time to make sure we're staying hydrated for our safety. As summer rolls around here in North Carolina, let's keep in mind how important it is to drink plenty of water and protect our skin with sunscreen. We've all got to stay mindful of those UV rays while we're out and about!

As summer approaches, rural carriers should prioritize safety with the following guidelines:

- 1. **Hydration:** Carry water and take regular breaks to stay hydrated, preventing heat-related illnesses.
- **2. Sun Protection:** Use a broad-spectrum sunscreen with at least SPF 30, applying it generously and reapplying it every two hours.
- **3. Appropriate Clothing:** Wear lightweight, light-colored, and breathable clothing for comfort and UV protection.
- **4. Footwear:** Opt for supportive shoes suitable for long walks to enhance safety and reduce fatigue.
- **5. Heat Awareness:** Be alert for symptoms of heat exhaustion and heat stroke, such as dizziness and fatigue. Seek shade and water at once if these occur.
- **6. Vehicle Safety:** Ensure vehicles are well-ventilated and avoid accidents when entering and exiting.
- 7. Route Planning: Schedule deliveries to minimize sun exposure during peak hours, if possible.

By following these measures, fellow rural carriers can safely navigate the summer months while maintaining their health on the job.

Mental Health, EAP and the Rural Carrier Benefit Plan

Another convention has come and gone, and I always learn something new. If you have never attended a state convention, it's an excellent opportunity to learn, make

your voice heard and hear the issues that fellow carriers are facing.

Let's talk about Mental Health and the options you have. Mental Health is an important issue and often ignored within us. EAP is a free service offered by USPS and is an excellent way to receive help by calling 1-800-EAP-4YOU. It is confidential and six sessions are covered at no cost to you. After those six sessions, your insurance can continue paying for the therapist assigned to you. The RCBP has in and out of network coverage allowing you to keep the same therapist or you can find a new one.

The RCBP plan also covers unlimited virtual visits through Teledoc at no cost!! This allows you to speak with a licensed therapist pr psychiatrist from the comfort of your own home. Another option is health coaching through Trestle Tree and again this service is at no cost. All these options are available at no cost and offered by the Rural Carrier Benefit Plan.

As always, my door is open and if you need guidance to utilize these options or have any questions, do not hesitate to reach out. It was great seeing all of you in person and thank you for attending the 2025 NCRLCA State Convention.


After all our guests we got into the business of the Constitution changes and the Resolutions.


We had three Constitution changes presented to the body from the Constitution Committee.

Four non binding resolutions passed. The rest of them failed. The ones that passed were:

- 1. That any USPS employee carrying a partial or total rural route as relief be required to log into the MDD as rural/RRECS as to not negatively impact the 52 week data capture by not entering data appropriately as required by RRECS.
- 2. So long as management has the responsibilities of

hiring and scheduling, carriers who are repeatedly scheduled into 2080/2240 violations should not receive letter of demand, face garnishment of wages or have funds removed from TSP for being in 2080/2240 violation by the actions of management.

- 3. A regular rural carrier is paid based on the evaluation of the route to which the carrier is assigned for the first 30 days of the temporary higher-level assignment. At the beginning of the next pay period following completion of the first 30 days, the carrier's salary is converted to that of a 40-hour evaluated route, attained step. The salary is then adjusted in accordance with the salary rules for changes under the salary schedule to which assigned, at the end of each fiscal year.
- 4. That the S008 standard be an actual time event of MISC time (during the MMS) if over the 0.7689 minutes per day or 4.6134 minutes per week.

We had five more resolutions brought up later under new business. Four of those passed. They were:

1. That the NRLCA advocates for collective bargaining input on AI implementation in the rural craft and transparency in AI data usage to safeguard employees.

- 2. Table 2 COLAs will be same rate as those of Table 1.
- 3. That the NRLCA will continue to support and encourage that Congress should take all appropriate measures to ensure that the United States Postal Service remains an independent establishment of the Federal Government and is not subject to privatization.
- 4. To keep in line with actual drivability of 50 miles

from duty station, that actual drivable distance over state/ federal highways be used as opposed to straight line measurement. (regarding local travel from duty office)

All of these passed resolutions will now go National to be to presented to the National Delegates. If they pass at the National Convention, then these items will be

up for negotiation in our next contract.

LEGISLATIVE UPDATES:

May 22, 2025, the reconciliation bill, H.R. 1 passed the House of Representatives with a vote of 215-214. Trump is hoping the bill will pass the Senate by July 4th. If passed as it currently stands, it would eliminate the FERS annuity supplement for certain employees. It would be effective January 1, 2028. This supplement allows rural carriers and other postal employees to retire before they reach age 62. It is designed to bridge the financial gap between early retirement and the onset of Social Security. Two provisions in the original bill were removed before it passed. The two that were removed were; the 4.4% contribution required by all active employees and replacing the high-3 with a high-5 calculation which would reduce retirement benefits.

H.Res. 70 "Expressing the sense of the House of Representatives that Congress should take all appropriate measures to ensure that the USPS remains

an independent establishment of the Federal Government and is not subject to privatization" has a total of 214 cosponsors. We need just a few more. Contact your Representative today. Also, S.Res. 147 still stands at only 7 cosponsors. Thom Tillis is one of the seven. However, Ted Budd is not. Ask for his support in this matter.

H.R, 1065 "Protect our Letter Carriers Act" has a total of 127 cosponsors. District 1- Donald Davis, District 2- Deborah Ross, and District 4- Valerie Foushee are the cosponsors from NC. On the Senate side, S. 463 has 7 cosponsors with neither of our Senators signing on.

H.R. 1522 "Federal Retirement Fairness Act" has a total of 102 cosponsors. District 1- Donald Davis, District 2- Deborah Ross, and District 4- Valerie Foushee are the cosponsors from NC.


One piece of legislation that has come back is H.R. 3011. "USPS Shipping Equity Act" with only 1 cosponsor.

Our grand total raised at the state convention was \$13,639.41.







After the closing gavel, the new board members met to choose our assigned districts and I had the pleasure to work with Caswell/Rockingham, Tri-County/N Wayne, Yadkin River, Six County and Mecklenburg districts this year. The following is my report of my duties during fiscal year 2024-2025.

Membership: Our membership as of June 2, 2025 is 5068.

On June 1, 2024 we had 5152 members. In 2023 (Continued on page 24)

we had 5114 members.

We had only 4918 members in 2022 on June 1st. On June 8, 2019 we had a high total of 5526 members. We had 5376 on June 20, 2020. We had 5355 members on June 15th in 2021.

As you can see, our membership numbers have decreased some from last year. I believe this is partly because the USPS is not hiring and filling the positions that are being left open when employees leave the Post Office. Your State Board attends as many new hire orientations as we can to recruit new carriers into our membership. Unfortunately 40% of these new hires separated within the year.

Our current membership consists of 2849 regular carriers; 209 PTFs; 1180 relief carriers; and 113 ARCs. There are 701 retired members. We also have 16 associate members.

I have processed 1125 new membership forms this fiscal year. 42 of those were regular carriers. Out of these new members, 435 of them were RCAs or ARCs that have already separated from the Post Office.

From our membership, we had a total of 57 regular carriers, 15 PTFs, 553 relief carriers and 41 ARCs that actually separated from the US Postal Service this fiscal year. These numbers do not include any carriers that were not members.

We had 46 members pass away this year.

There were 28 regular carriers that canceled their membership this year. Twelve of these have left the craft for management positions.

Non Members: North Carolina currently has 2943 non-members in our craft. There are 1378 regular carriers, 63 PTFs, 1019 RCAs and 483 ARCs that are not members of the union.

I want to remind you that our National office still has the **Recruit A Friend Today (RAFT)** incentive program. You will receive \$15 for each RCA or ARC that you recruit and \$50 for each regular carrier or PTF that joins.

Please encourage **all** carriers to join the NCRLCA. We need members. We have strength in numbers.

Department of Labor: As a recognized labor union, one of the biggest challenges of the NCRLCA is to deal with matters of law that apply to the NCRLCA and all of its subordinate units. It is the responsibility of the Secretary/Treasurer to comply with these laws by submitting in a timely fashion all required Department of Labor Law reports.

The LM 2, which is the financial report from the state to the Department of Labor (DOL), was

prepared at the close of our fiscal year and submitted to the DOL in September. Also, all of our local districts are required to submit a LM 4 report to the DOL within 90 days of the close of the fiscal year. All 31 reports were done by me as the administrator for the districts. Copies were sent to each district secretary to keep with their district records.

All of these reports are of public record and can be seen on the DOL website.

IRS and NC Department of Revenue: It is the responsibility of the Secretary/Treasurer to submit biweekly all taxes withheld from employee paychecks to the IRS and NC Department of Revenue. Annual and Quarterly reports are required to be submitted to each also. All reports were submitted on time as required.

The North Carolina Dept of Commerence called for an audit of our books this year. This is a standard practice. They normally do this every five or so years. They looked at our records for the 2023 year. I am happy to report that our recordkeeping is fine with no discrepancies and no adjustments needed.

I also have to file the 990's for the State and all local districts to maintain our non-profit status. These are due in November every year. All 990's were filed prior to the due date.

Travel and Meetings: This year I have attended new hire orientations or rural academy classes for the purpose of recruiting new members to our ranks. I attended our State Convention in June, the National Convention in August, the Fall Booster in October and SAC in January. I also attended four board meetings in addition to these meetings. We did have a couple teleconference or Zoom meetings as a board.

I went to five local spring district meetings. I toured the venue for our 2026 Convention with President Althoff and Vice President Schreiber. I also met with our Executive Committee so that they could do an audit of our books.

I have driven 4.094 miles on association business. I had fifteen overnight stays this year.

Financial Report: I have meet with our Executive Committee on three separate occasions so that they could do a complete audit of our records. That report will be presented at the State Convention.

The CPA firm of Sherrill, Blake and Harrison reviews our records every year at the close of our fiscal year. A financial report will be printed in an upcoming issue of the *North Carolina Rural Carrier*.

President Althoff, State Board and fellow rural carriers, this is the North Carolina Rural Letter Carriers' Historians Report for the year 2024-2025.

On June 17, 18 & 19 2024 the 119th Annual State Convention of the North Carolina Rural Letter Carriers' Association and the 98th State Convention of the Auxiliary was held at the Great Wolf Lodge in Concord, North Carolina. NRLCA Director of Labor Relations Bridget Bosek was our honored guest.

We had a lot of business to attend to this year. Three Constitution changes were presented to the body. Only one passed. It was to remove the language requiring the Fall Booster to be moved around the state.

We also had a total of twenty resolutions to consider. Six passed. The rest of them failed. The ones that passed were:

- 1. Whereas currently there is no way to account for large amounts of carrier sort mail received the day after a holiday. Be it Resolved That the USPS, with input from the NRLCA, develop a reporting program to capture this data from carriers in the field.
- 2. If an office has received USPS vehicles and those vehicles are not being utilized consistently to run full rural routes, not just for splitting routes, that these vehicles be assigned

to routes that are making multiple trips per day on a regular basis. Further if the office is on a list to receive vehicles routes making additional trips need to be considered for USPS vehicles first

- 3. As first assured/promised, RRECS data will be available to carriers assigned to a route.
- 4. Offices should be provided with extra scanners during peak season so carriers can be paid correctly when being given auxiliary assistance by a RCA.
- 5. PTFs and RCAs if required to work Sundays and/or holidays will be compensated at 150% of their hourly rate for the hours worked regardless of the hours worked for the week.
- 6. That the NRLCA resume and renew their commitment to the Provident Guild and recognize it as a valuable asset to the NRLCA membership and their spouses.

All of these passed resolutions went to the National Convention and were presented to the National Delegates. If they passed at the National Convention, then they will be negotiated for in our next contract.

NC NSS Fiscal year end of year report.

We streamlined where step 2 grievances only go to one location instead of 2. They all now go to Greensboro NC along with all disputes.

A copy of All disputes now only goes to the District Representative and to the "Manager of Labor, Attention: Disputes."

The ADRs are now hearing their own step 2 grievances with the Labor Reps to assist in getting cases heard as quickly as possible.

Current list of work totals for the year for the state:

• Yearly Grievance Totals: 1,343

• Yearly PDI's: 1,352

• Yearly Class actions: 116

• Yearly Individual grievances:952

• Yearly Discipline grievances: 292

• Closed at step 1: 1095

• Closed at step 2: 199

• Closed at step 3: 3

• Currently open at step 2: 46 grievances.

• I drove a total of 3970 miles in my POV and a total of 7,776 miles in a rental completing DR duties.

• I did 32 Investigative interviews

- I resolved 40 step 1 grievances.
- I resolved 112 step 2 grievances.

I Attended 9 LSET training courses across the state with assistance from the ADRs for the yearly required training to remain a steward. The response to the new Enhancement training has been overwhelmingly good. The stewards enjoyed the scenarios and getting to ask questions from the ADRs for real life experiences.

Currently we have 9 offices listed that have gone through, are going through or will be scheduled to do MOU 25. They are Wake Forest, Kinston, Cary, Randleman, Liberty, Wilson, Newport, Albemarle, Apex. We have one office with an agreement to do

We now have ADR's Gail Naillon, and Elissa Gonzalez assisting with the academy trainers. They are working to get more instructors in place so we can get more people hired and in the offices.

We have ADR's Amy Russo and Ralph Fernandez assisting with hiring efforts. Job fairs, hiring meetings, and additional non-managerial duties to help our craft hire as assigned by the DR.

ADR Tabitha Benfield is assisting with the phantom routes across the states for all the employees that have been on workers comp for more than 2 years. It is slow, but we are making progress. Some of the older ones may have to go to the Area Level to correct if they will not give the District DSS access to fix the issues.

We had a total of 251 disputes for Spring MMS five. 88% of the disputes have already been heard and have been sent to DSS to be entered for corrections. Some of the other disputes will be impassed to the Area level and some we had a few more questions about to get corrected. They will be completed soon as well if not completed already on 06-12-2025.

ADR Kelly Futch was named number 2 to cover for me when I am not available and for other assistance to the DR to run the state of North Carolina.

ADR Nathen Darden has assisted with catching up the back log of step 2 grievances. We worked together for a week reading through over 50 step 2 grievances coming up with fair settlements for our carriers per the contract.

ADR Angela Morrow was assigned Charlotte. Anyone that knows Charlotte knows it is one of the toughest cities in the state. I commend Angela, Kathy and Tamara for taking care of our Charlotte carrier's.

The longest day Eddie and I worked together was 14 hours. The longest day I worked catching up the back log was 17 hours. My longest week since taking over NC, is 97 hours.

The ADRs and I are building and working relationships with the District Manager Scott Manier, his right-hand Rural person Corey Williams, the Manager of Labor Relations Sheena Hazel, The Manager of Human Resources Doris Reed, District Delivery Support Specialist, Tim Forman, Labor Relations Specialist's Alex Varghese and Vernice Jones, most of the POOMSand MPOOs. This has assisted in getting step 2 cases heard, holding some managers accountable for bad behavior, getting RFI's filled in a timely manner, getting 204Bs back on their routes that are over 180 days and on and on.

Remember that if you call your steward and they do not answer to give them some time to call you back. They may be running their route or on another call or in a meeting. In the year to come I hope to focus more on training and making sure our stewards are all getting the same information and getting the things they need when they have grievances.

With the implementation of RRECS, we have come to realize that proper scanning is vital for the evaluation of a route to be correct.

Mapping is as well but as an RCA proper scanning is your responsibility. We recognize brand new RCAs are focused solely on surviving the day without crying! Once the "new" is no longer a factor, all RCAs should understand the importance of proper scanning on any route that you are carrying.

Most RCAs must work over 40 hours a week. Because of this, paid evaluation may not seem important. Oh, but it is! Our District is in the process of 100's of route adjustments. One of the newly created routes may be the route you become a regular carrier on. This is why it is so important that all the work associated with a route is captured through our scanner.

Load time has no limits. We can have multiple load times; we just have to have equal start loads and end loads. Load time is credited as actual time. It is not a race to load the vehicle. On the other side of the coin, we should not be using our load time for what would qualify as our "lunch break" time.

Please do not let management rush your load

time to the point you are not organized. Management always has the right to observe our work practices and offer suggestions. If you are splitting routes and you are loading more than one route, remember to change over to the proper route number as you load. RRECS was not designed for splitting routes. The proper way to deliver in this situation would be to time load and go deliver one route, then return to the office and time load vehicle and go deliver the next route.

Any day you have a boxholder to deliver, remember to enter hot key 4 for flats or hot key 5 if

the boxholder is letter size. Authorized dismounts hot key "B". If this dismount requires additional trip(s), beyond the initial trip you will enter the total trips it took you to serve that dismount. For example, most carriers are not able to carry all the mail to serve a CBU on one trip. If you take letters and flats on the first trip and then go back to the vehicle for parcels, you will enter 2.

There is ongoing confusion on management's part of the definition of an "unscanparcel". Hot key "C" is for any obvious parcel (not a flat or a letter) that has no barcode, or the label is missing or unreadable regardless of the size of the mailbox or whether the parcel will fit.

If we sell a stamp on the route, there is a key to that. Hot key "N" would be used. It is not to be used when you purchase stamps to sell on the route. This is included with end of shift duties.

Remember to return2du, hot key "J" AFTER you turn the vehicle off and BEFORE you exit the vehicle.

A daily zero-scan report is available for the office. The stewards have access to this report as well. There are usually more than one thousand routes every delivery day that are still doing the basic 6 scans. This means there are more than one thousand routes that are being shorted the proper credits. We have carriers that will start load, end load, and depart to route in the same minute. We have carriers that will return to the office and clock out for the day at the same minute. We know both examples are impossible. We have carriers that never have an additional authorized dismount even on the day after a holiday. We know this is impossible. Please give the route you are working on every proper scan it is due.

I encourage all leave replacements to stay focused on their daily work and keep in mind this route you are serving today may be "your" route soon. We want the evaluations to be correct for all. It is your money. Article 34.1 in the National Agreement states "The principle of a fair day's work for a fair day's pay is recognized by the parties for this Agreement". By utilizing every hot key when it is appropriate, you will ensure proper compensation for the route you are delivering today as a leave replacement as well as when you become a regular carrier.

NRLCA and USPS Working Together For A Common Goal Of Safety

The District Manager Scott Manier and I, Cliff Workman, are working diligently for carriers' safety.

We have reduced carrier incidents of not wearing their seat belts from upwards of 25% down to roughly 3% with seat belt notifications for carriers to properly wear their seat belts.

Both the Union and management worked together to get the information out on proper seat belt usage. We did have a few carries that refused to listen and were placed on emergency placement for not following safety. They were returned to work the next day in most cases.

These policies must be followed. These initiatives have reduced accidents and injuries across the state

and the country; however they have not been reduced completely. This is unacceptable to the District Manager and unacceptable to me as your District Representative.

Safety is our number one goal and priority. We want everyone to go home safe. We have had several fatalities in this last year. "Please take a moment of silence in their memory."

SEAT BELT POLICIES

All seat belt policies can be found under "seat belts" in the Steward Reference Guide. The steward reference guide is available to all Union members on the NRLCA.ORG website. Go to Steward Operations, then the steward reference guide to get to it on the website. Our stewards use this site every day to look up issues related to your contractual matters.

If your vehicle is in motion your seat belt should be buckled. In an LLV you may unclasp the shoulder belt under certain circumstances.

If you are in a vehicle that the seatbelts do not unclasp, then your shoulder belt is required to be worn unless you cannot reach the mailbox for delivery. You may unbuckle the seat belt to deliver the mail and then buckle it back up.

All this documentation can be found in the

Steward Reference Guide. There is also a step four in the Steward Reference Guide regarding seat belts for seatbelts that do not unclasp.

Stay safe out there and drink plenty of water during these hot summer months. Take breaks and rest in the shade when needed.

Reach out to your assigned steward or follow the chain of command when contacting a steward for questions.


They elected new officers and Elizabeth Sullivan installed their new officers.
